**RESOLVED** that the Chair was declared vacant and nominations were called. Des Williams was nominated and was unanimously elected to Chair the meeting.

Jackie opened the meeting with a welcome to all present and paid respect to Elders past, present and emerging.

#### Agenda Items:

### A1. Wardrop Valley Tiny Homes Village Presentation – Councillor Ron Cooper

Cr Ron Cooper explained the background and gave an overview of the Wardop Valley Tiny Homes Village concept.

The group discussed the scope, sustainability and community aspects of the project.

Helen Carter, Acting Unit Coordinator Community Services, explained that Council has an overarching Community Development Strategy that helps address some of the topics discussed and that Council has a team of Community Development Officers who help to implement the Strategy. Helen noted that any next steps with the project would need to be considered within the context of the Council-adopted Community Development Strategy.

The AAC discussed the scope, sustainability and community aspects of the project. Some AAC members raised concerns about the proposal particularly without a clear needs

analysis having been presented, an apparent lack of clarity about the particular target group the housing is intended to support, and the location, given its remoteness.

#### A2. Norries Head Concept Design Project – Stewart Brawley

Stewart Brawley, Manager Parks and Active Communities, gave a brief overview of the upcoming Master Plan for the Parkland area on Norries Headland, Cabarita. Stewart highlighted the Shire-wide Open Space Strategy incorporating a number of community priorities. A number of areas required a Master Plan and Norries Head was identified through this process. Council is in the initial stages of the project, Dan Plummer, of Smith and Plummer Landscape Architects, has been commissioned to help with the design of the Norries Head Master Plan and we are beginning to engage the community for feedback on the project. Stewart explained that at this stage it was just for information and that as the project progresses he would return to the AAC to provide updates and to seek input from the Committee.

The group discussed the area that would be included in the Master Plan. It was raised that there has been considerable erosion on the headland and the Committee also reminded Council that the whole site is a Midden Area. Stewart acknowledged this and understood that an Aboriginal Cultural Heritage Assessment (ACHA) would need to be completed.

Jackie McDonald advised that she could provide photographs of the area before it was initially developed to Stewart.

Leweena Williams expressed concern that the area is being heavily used by tourists. Stewart acknowledged this and explained that they will be designing the area with the local communities' values in mind so that we can better manage the key functions of the area.

#### A3. Recommendation on Closure of Letitia Road, Fingal Head

The group discussed the extension of the closure of Letitia Road beyond the current date of 1 March 2021. Currently the road is closed to vehicles, but pedestrians and cyclists can still access the area.

It was discussed that the Committee members would consult the Fingal Head Elders and community members to consider longer-term options, e.g. shutting the road permanently.

**RECOMMENDED** that Letitia Road, Fingal Head, stay closed until 1 September 2021.
