# Do the right bin – it's costing us all

**Council's Director Community and Natural Resources, Tracey** Stinson had first-hand experience of picking up bins when she took a trip in a green waste collection truck with Council's waste contractor, Solo.

"It was a great experience and really interesting to see how far technology has come," Ms Stinson said.

"All the trucks have cameras on both sides and up above so they can take photos of the contents of the bin as it is lifted into the truck.

"And the driver – Steve – was very skilled at manoeuvring that big truck in some very tight spaces and turning circles. He also knew which bins were more likely to be contaminated and could jump out and check before picking it up," she said.

If it is contaminated – the wrong items are put in the bin – a sticker is put on the bin to warn the resident and it is pushed back from the kerb.

"This is obviously time consuming and costly. "Unfortunately many people are still putting the wrong items in their green bin, which is increasing waste management costs for Council and ratepayers.

"When we introduced the green bins over 12 months ago, Tweed had one of the lowest contamination rates in the country at less than one per cent. We are now back up over four per cent contamination and that unfortunately means that sometimes whole truck loads have to be re-sorted manually before being sent away for processing into compost," Ms Stinson said.

"This is a very expensive process and will result in increased waste charges for the community.

"It's worth us all doing our bit to make sure no plastic goes into our green bins – if in doubt, put it in the red bin.

"Like you, Council is committed to protecting and enhancing our environment for current and future generations, and to ensure we are giving rate payers value for money through the services we provide," she said.

### Plan ahead for roadworks

No one likes to be delayed by roadworks but chances are most motorists will be caught out from time to time across some of the 1200km of roads in the Tweed.

So, if it's critical that you get to your destination in time to catch a flight or attend that appointment, the best advice is to leave early so you are not delayed by unexpected roadworks.

Council advertises roadworks in a number of ways, depending on where the road is and how much traffic it carries. There is on-site signage, direct letter drops to residents, updated information on Council's website at www.tweed.nsw.gov.au/RoadWorks and whole-of-region information at <u>northernrivers.myroadinfo.com.au</u>

But, from this week Council is extending its roadworks advice to your favourite device. To get a heads-up on any roadworks on our major arterial roads, 'like' or 'follow' Tweed Shire Council on Facebook.

### **Delays for Terranora upgrade**

There will be roadworks on Terranora Road between Fraser Drive and Sunnycrest Drive for the next seven to eight weeks.

Work hours are 7am to 5pm and the traffic is down to one lane through the construction zone.

Council knows there is no practical detour for most people, however, please avoid the area during these times if possible.

Nightworks aren't practical because residential houses are close by. Council crews are monitoring delays and will do all they can to reduce disruption.

Similar rehabilitation works are starting on Thursday on Tweed Coast Road at Pottsville between the bowls club and the school. This section will be down to one lane between 9am and 2pm. Please plan your trip to accommodate any likely delays.

# Avoid the sun trap and do your solar research

While many Tweed householders are considering installing solar to save money and help the environment, it's important to do your homework.

Council's Sustainability Program Leader Debbie Firestone, encourages anyone interested in solar to check out Council's Solar Buyers Guide to ask all the right questions when getting quotes from suppliers.

She also warned buyers to be wise in the face of tricky sales tactics

"Members of the community have reported some solar companies making false claims about being contracted to



Tweed Shire Council to promote solar. This is completely untrue," Ms Firestone said.

"We're also aware of sales people putting pressure on customers to sign up to solar deals Council recommends you:

- Use suppliers with a long track record of expertise in solar
- Check the installer is accredited with the Clean Energy Council · Use the websites listed in the Solar Buyers Guide to check
- you're getting good quality equipment, especially inverters.

"Take your time understanding what's on offer and how it will benefit you. These decisions have a big price tag, and can be really worthwhile in the long run as long as you've got good local support from your supplier to iron out any faults," she said.

"Our community should be proud that over 35 per cent of local Tweed households have solar, the highest in the Northern Rivers.

"Solar is a smart way to switch to clean electricity and reduce greenhouse gas pollution, and for many the price is right. "We're supporting the community to minimise their negative

# Wheeling out support

Tweed Regional Aquatic Centre (TRAC) at Murwillumbah has two new purpose-built wheelchairs for use in the hydrotherapy pool.

One was purchased by Council and the other was a gift to the community from the Rotary Club of Murwillumbah Central.

Costing \$2000 each, the chairs are made from hard PVC and toughened aquatic mesh designed to stand chlorine and regular immersion in water. They can also take up to 150kg in weight.

Operations Coordinator Aquatic Facilities, Jo Hogg, said the wheelchairs were essential for getting people with mobility issues in and out of the hydrotherapy pool.

"These chairs ensure the benefits of hydrotherapy are able to be enjoyed by as many people as possible," Ms Hogg said.

"It's great to be able to replace our former chairs, which had reached the end of their life, as it's such a tough environment.

"We're grateful to Rotary for providing this support to the community," she said.
