# Our environmental leaders of the future

Eighteen remarkable students from high schools throughout the Tweed recently took part in the Tweed Schools' Environmental Leadership Program.

The program involved a three-day wilderness experience in and around Clarrie Hall Dam with Outward Bound Australia, who have a base at nearby Kunghur.

Through canoeing, hiking, camping and group activities, the students demonstrated exceptional teamwork, problem solving, communication and determination.

Council's Senior Program Leader – Biodiversity Scott Hetherington was inspired by their resilience, including their composure and positive attitudes after hiking many kilometres through the rain carrying full backpacks.

"The students responded to any and every challenge in really positive and collaborative ways. They worked really well together and tackled challenging tasks and activities with confidence and maturity well beyond their years," Mr Hetherington said.

"It is so encouraging to know that this group of young people are out there and making a positive difference for all of our benefit," he said.

On the final day, the students had a sustainability leadership workshop where they explored leadership styles, how to change behaviour and implement environmental projects.

This was the second year this initiative funded by Council was held and the program will continue again next year.

# **Hazard reduction burn**

Council and the NSW Rural Fire Service have been working together to plan a hazard reduction burn in Pottsville Environment Park.

The Pottsville Environment Park will be closed on Sunday 4 August from 6am, subject to favourable weather conditions.

Signs will be placed at the park to notify of the closure and Council will manage the park's access points on the day of the burn.

The planned burn will reduce the likelihood of wildfire, protect park assets and wildlife habitat, and reduce the potential threat to nearby residential areas.

Planning the burn has involved a detailed assessment of potential environmental impacts, in particular the resident koala population. Burning under controlled conditions in the cooler months will help to ensure it does not impact koalas or their habitat. There are a range of other actions such as pre-burn surveys and raking away the fuel around habitat trees that will also be done to reduce the risk to koalas and other wildlife.

Council's Senior Program Leader for Biodiversity, Scott Hetherington, said that low intensity fire is an essential part of looking after our local plants and wildlife.

"Many species, including koalas, would not occur at the park without fire as the gum trees that koalas depend upon rely on fire to create favourable conditions to grow," Mr Hetherington said.

"Burning smaller sections of the park at a time allows wildlife to move into adjoining areas while still reducing the likelihood of an unplanned fire spreading throughout the park," he said.

# Temporary tip shop closure

The Stotts Creek Resource Recovery Centre 'Tip Shop' will be closed for at least the next six weeks while renovations are carried out to provide an improved service focusing on less to landfill.

Earlier this month. Council resolved to take over operations of the facility to better manage the site during major upgrades to infrastructure and roads at the site over the next few years as part of the Stotts Creek Resource Recovery Master Plan.

Council's Director Sustainable Communities and Environment Tracey Stinson said the upgraded tip shop would have a greater focus on building awareness and giving people more opportunities for 'less

"Within the short term, we want to expand its operations into other 'less to landfill' initiatives such as a tool library, repair workshops and art from rubbish," Ms Stinson said.

"It's all about 'less to landfill' and looking for innovative ways for repairing, upcycling and giving items a longer life."

"We know customers love the salvaged items available at the shop and we will continue to offer that service when we reopen in approximately six weeks," she said.

"We will still be collecting items which can be reused, recycled or upcycled from landfill while the tip shop is closed." The previous operators, St Vincent de Paul, wished Council well. Visit
