Smiley radars remind drivers of speed limits

Council's road safety team have trialled a portable radar on Casuarina Way that flashes a red sad face to speeding drivers and a green smiley face to drivers who are obeying the speed limit.

Road Safety Officer Alana Brooks said most drivers wanted to do the right thing and the interactive signs gave drivers instant feedback and reminded them about the speed limit.

At the two locations on Casuarina Way, Casuarina, speeds have dropped by an average of seven kilometres an hour.

Before placement of the smiley face radar, a site north of Windsong Way recorded that 58 per cent of vehicles were travelling over the

50 kilometre an hour speed limit. When the sign was present, only seven per cent of drivers were doing the wrong thing.

"The signs are a great community awareness tool, encouraging drivers to check their speed and acknowledging good driving behaviour," Ms Brooks said.

While Council has only one smiley face radar sign at this stage, funding applications have been lodged with the NSW Government for more.

Locations for the signs will be prioritised based on known speeding problems, on-going community concern, a high number of vulnerable road users and/or a recorded crash history.

Help clean up the Tweed

Volunteer registrations for Clean Up Australia Day 2020 are open, with an appeal to Australians to step up on Sunday 1 March to reduce the amount of waste in the environment.

Clean Up Australia Chairman Pip Kiernan said Australia creates 2.5 million tonnes of plastic waste each year.

Only 12 per cent of this is recycled, with the rest ending up in our parks, roadsides, bush, waterways, oceans or in landfill as rubbish.

Clean Up Australia Day is the nation's largest community-based mobilisation event and last year more than 680,000 volunteers removed over 15,000 ute loads of rubbish from the 6901 registered locations across the country.

Council is providing the collection of bagged waste and recycling to registered community groups and Council's waste contractor Solo are providing skip bins for larger collection points.

Water restrictions lifted

Water restrictions across the Tweed have been lifted following 200mm of rainfall in the catchment area in recent days.

Clarrie Hall Dam is now at 100 per cent and there are significant river flows at Bray Park Weir.

Residents and businesses can return to normal water usage but everyone is encouraged to continue any water saving habits for the long term.

The dam level rose from 82.5 per cent on Wednesday 5 February to 100 per cent on Sunday.

The rain has caused a number of maintenance and safety issues in our public parks and these take priority over turning back on beach showers and taps, so please be patient as we work through this. It may take up to two weeks.

No further business restriction permits will be issued and any business with a Level 2 Restriction permit has now expired.

New social enterprise café in Tweed Heads set to open

A new café is set to open in Tweed Heads this month that is good for people, good for the community and good for the planet too.

Located in the newly-upgraded plaza precinct at the Tweed Heads Civic and Cultural Centre, the Brett Street CAFE (Community Access For Everyone) is opening to the public on Monday 17 February.

The café is a social enterprise initiative of Tweed Shire Council and will be a convenient and welcoming place to grab a coffee and healthy snack while knowing that the money you spend is doing good.

Income from the café will support the delivery of Council's Community Services programs such as MisterChef, which supports older men who may need to learn to cook for themselves. Another program is Stand Together, which provides knowledge about reducing the risks of falls and how to prevent them.


The café is the last piece of the \$1.2 million Tweed Heads Civic and Cultural Centre redevelopment, which is now complete.

Less to Landfill

Ten things you should know before you go

Less than five per cent of people have a plan for their end of life and 45 per cent of people die without a will.

These are two of the 10 topics that will be covered in a three-hour workshop run by Compassionate Communities Northern NSW, in collaboration with the Groundswell Project, which is part of the Tweed Seniors Festival from 12 – 23 February.

The workshop will encourage residents of the Tweed to start thinking about death and the benefits of early palliative care referral to assist in living longer and with a better quality of life, in partnership with Tweed Shire Council.

Guest speaker and end of life consultant Mimi Zenzmaier from Sacred Earth Holistic Funerals will address do-it-yourself, at-home funerals as a way for families to say goodbye to a loved one within a home environment, as well as the value of having the dead in the presence of family members at the end of life.

Cemeteries Business Manager Helen Carter said the Council initiative to partner with Compassionate Communities was part of an ongoing community discussion on 'doing death well' which began last year.

Other topics to be covered in the three-hour workshop include expected deaths, the community preference for cremation and why health care professionals die differently from non-health care

The workshop will be held at the Tweed Valley Cemetery at 813 - 873 Eviron Road, Eviron on Tuesday 18 February from 1pm to 4pm. Entry is by a gold coin donation, with afternoon tea and light refreshments provided.

Increase in dog attacks

Council's rangers have experienced an alarming increase in the number of dog attacks reported over the summer months, with many of these being extremely serious.

Complaints have also been received relating to dogs off leash, particularly on coastal areas such as beaches and creeks.

Council's Director Planning and Regulation Vince Connell said there were also complaints from dog owners who are using on leash areas to exercise their dogs but are concerned by the number of dog owners who do not restrain their dogs in public areas.

"In January, rangers responded to approximately 22 dog attacks compared to 7 in December – and 62 call outs for unleashed or roaming dogs compared to 33 in December." Mr Connell said

"Given the scope of the rangers' duties, this is a significant workload which could be reduced by owners understanding and adhering to the principles of responsible pet ownership."

Council rangers will continue to conduct increased patrols throughout the Tweed. Enforcement action will be taken where an offence has been detected. Any dog not secured by a lead in a public place attracts a \$330 on-the-spot fine and a dog involved in an attack attracts a \$1320 on-the-spot fine or the potential to be prosecuted in court.

"Council is urging pet owners to comply with all laws relating to owning a dog by making sure adequate fencing is in place to prevent a dog from escaping a property, as well as ensuring that a dog is secured by a lead any time it is in a public place," Mr Connell said.
