Council-managed playgrounds, outdoor exercise equipment, skate parks and barbecue facilities have been temporarily closed to the public until further notice, as part of Council's response to coronavirus (COVID-19). Ninety-two playgrounds, 51 barbecue facilities, three skate parks and seven outdoor fitness facilities have closed as a proactive and precautionary response to protect the safety of the community.

## **Council services update**

Here's an update on the status of Council services during the COVID-19 emergency.

Services continuing to operate as normal

- Water and waste services are running as usual so please make sure you put your bin out in time for collection.
- ✓ Stotts Creek Resource Recovery Centre open (Tip Shop closed). Services temporarily closed until further notice
- Cultural facilities library branches at Tweed Heads. Kingscliff and Murwillumbah; Tweed Regional Gallery & Margaret Olley Art Centre and Gallery DownTown; Tweed Regional Museum at Murwillumbah, Tweed Heads and Uki.
- **Community facilities** community centres and their programs at Banora Point, Tweed Heads South, Kingscliff Community Hall, Tweed Heads Auditorium (Murwillumbah Auditorium currently closed for repairs).
- **Swimming pools** aquatic centres at Murwillumbah, Kingscliff and Tweed Heads.
- **Tourism facilities** visitor information centres at Tweed Heads, Murwillumbah and Kingscliff. Tweed Holiday Parks at Fingal Head, Kingscliff North, Kingscliff Beach, Hastings Point and Pottsville South will close effective Wednesday 25 March 2020 at 6pm. Pottsville North and Tweed Heads remain open to offer accommodation to customers living in RVs.

## **Wollumbin/Mt Warning** summit track closed

To protect the health and safety of visitors and staff, NSW National Parks & Wildlife Service will temporarily close all campgrounds, visitor centres, high visitation areas and historic sites across NSW until further notice. This closure includes the Wollumbin/ Mt Warning summit track.

National parks remain open (at the time of going to print) including most walking tracks and trails and visitors should observe necessary social distancing with others while using pathways and facilities.

## No wet wipes in the loo

Council is encouraging the community to help prevent sewer blockages and spills by avoiding flushing any toilet paper alternatives down the toilet.

With many people turning to tissues, wet wipes and even paper towel to use in the toilet, customers are reminded that these items simply aren't flushable and can have serious consequences for the environment and community.

Only flush the four Ps; pee, poo, puke and toilet paper.

Tissues, wet wipes and hand towel are made from a robust weave, not designed to disintegrate easily. They combine with fats, oils and grease in the sewers and create massive fatbergs that block the network and cause spills.

## Minimise your tip trips

Council has temporarily closed the Tip Shop until further notice. The Stotts Creek Resource Recovery Centre (the tip) remains open to the public.

Council is asking our community to help keep our landfill operating staff safe by minimising your trips to the Stotts Creek Resource Recovery Centre (the tip). We understand that people are at home with time on their hands – so please go ahead and have a clean out – but just stockpile any items that you would normally take to the tip unless it is absolutely critical to dispose of them, just until we get through the COVID-19 crisis.

Waste and recycling collection services remain unchanged and these essential services will continue.

### **Local government** elections postponed

The NSW Government has postponed the September local government elections for 12 months to September 2021, to address the risks posed by COVID-19.

Tweed Shire's current councillors will continue to hold their civic offices until the rescheduled local government elections.

The next mayoral election (voted by Councillors) will be held in September 2020. The next election for Deputy Mayor will also be held in September 2020.

The postponement of the next election will not change the future schedule of council elections, and the subsequent election will still proceed in September 2024.

## **Queensland-NSW border** restrictions in place

To slow the spread of COVID-19, the Queensland Government has been restricting entry to Queensland since last Thursday.

Travel should be minimised as much as possible.

The restrictions still allow people to undertake essential travel between their residence and place of work. This should be limited or minimised due to the need to reduce travel as much as possible. This also applies for people who live in Queensland, and work in NSW.

The movement of essential goods and services will continue.
