### Roadmap means some changes to Council services

Stage 1 of the NSW Government's roadmap for easing COVID-19 restrictions began on Monday (11 October), requiring changes to some Council operations.

Under Stage 1 of the roadmap, which kicked in across NSW on Monday, all patrons attending some Council facilities, are now required to be fully vaccinated (or hold a medical exemption). This is in keeping with the latest NSW Health Public Health Order (PHO), which took effect

The PHO has impacts for Council operations and business areas. including the imposition of density limits for events and venues, requirements to ensure face masks are worn, taking adequate precautions not to allow unvaccinated adults (more than 16 years of age) onto certain premises, work from home arrangements and directions for stay-at-home orders if a person becomes infected with COVID-19.

In keeping with these new requirements, Council has developed a comprehensive plan which required changes at some of Council's customer-facing facilities, including the requirement to be fully vaccinated to enter the following facilities:

- · Tweed Regional Aquatic Centres (TRAC) at Murwillumbah, Kingscliff and South Tweed.
- Tweed Regional Gallery & Margaret Olley Art Centre
- Tweed Regional Museum
- · indoor venues at Council's cemeteries
- . Banora Point and Tweed Heads South community centres and

- markets that are Council approved on Council land
- Visitor Information Centres
- · village community halls, places and spaces where they are used for certain activities including recreation facilities, weddings and funeral services.

Council's auditoria at Murwillumbah and Tweed Heads hold an additional requirement to ensure a child under the age of 16 attending these facilities must only do so if accompanied by a fully-vaccinated adult household member.

Vaccination status is not required at Stotts Creek Resource Recovery Centre (tip) which will continue to operate under COVID-Safe conditions for domestic and commercial operations. Tweed JUNKtion Tip Shop will remain closed.

Council meetings will be held in the Harvard Room at Tweed Heads Administration Office. Anyone wishing to attend in person must pre-book their seats due to capacity restrictions. Meetings will also be livestreamed. Details on how to book or join the livestream are available on Council's website.

Library branches at Murwillumbah, Tweed Heads and Kingscliff are restricted to 'Click and Collect' services only (see separate story in this issue of the Tweed Link).

Essential services including water and kerbside waste collection services continue to operate as normal.

### **Click and Collect at your local library**

All Richmond Tweed Regional Library branches will only provide 'Click and Collect' services from 11 October to 1 December.

This includes libraries at Tweed Heads, Kingscliff and Murwillumbah. The decision is based on a balance between:

- meeting the requirements of the Public Health (COVID-19 General) Order 2021 commencing 11 October 2021
- · delivering quality services to library members and visitors
- · staff safety and well-being concerns
- · member Council views.

The 'Click and Collect' service allows library members to reserve and safely collect library items. It has operated successfully across the library network when required.

Library members can reserve items, book a collection time, mask up, check in and show their library card at the door to collect items.

You can reserve items on the library catalogue (accessible from the library website) or staff can select up to 20 items for you. Bookings are essential to access this free, contactless service.

Library branches are closed for all services other than 'Click and Collect' and the online library until 1 December.

## Leaf cactus: aka Satan plant

Originally introduced into Australia for its attractive flowers and unique fruit, Leaf Cactus now sits on the Australian Environmental Alert List. Here in the Far North Coast, there are six known locations of Leaf cactus which are being actively managed by Rous County Council.

Leaf cactus or 'Satan plant' is a vine that grows in dense clumps and has long thin spikes which sprout in clusters along branches making control of the weed difficult.

Once established, the plant seeks out the trunk of a nearby tree and will gradually climb up to form dense thickets in the branches and canopy.



This weed is a threat to eucalypt communities in subtropical northern Australia.

Leaf cactus can reproduce vegetatively via leaf or branch droppings and by seed dispersal where it may be carried vast distances by birds.

With only six known locations of this weed in our region, Leaf cactus is currently listed as a regional priority for eradication.

**Biosecurity is everyone's duty** and with community assistance we can be rid of this weed in our region once and for all.
