Spring clean with a visit to your local CRC

It's National Recycling Week next week (8 - 14 November). You may not know that household batteries, oils and fluoro light bulbs can all be recycled into new products, but not if they get thrown into kerbside bins where they end up in landfill.

In the last 5 years, 216 tonnes of this kind of household problem waste as well as paints, gas bottles, fire extinguishers, car batteries, motor oil and smoke detectors, have been dropped off at the Tweed Community Recycling Centre or CRC for recycling or safe disposal.

So, whether you're moving house, renovating your home or just having a good old spring clean, take the opportunity this National Recycling Week (or in fact any week of the year) to drop off household problem waste for free. Visit the Tweed CRC, located at Stotts Creek Resource Recovery Centre, Ledday's Creek Road, Stotts Creek.

To make it more convenient for Tweed residents to recycle small quantities of household problem waste, including household batteries and mobile phones, Council and North East Waste have installed free Community Recycling Stations at:

- Murwillumbah Civic & Cultural Centre
- Tweed Heads Civic & Cultural Centre
- Pottsville Beach Neighbourhood Centre (at the Technology Centre) – new location!

Australia Day 2022 community events in the Tweed

Barbeque breakfasts, art competitions, photographic displays, cards games and a cricket match are among the activities across four Council-sponsored community events to celebrate Australia Day on Wednesday 26 January 2022.

Following a call in October 2021 for applications to support small community events across the Tweed Shire, Council awarded funding to:

The South Tweed Over 50s Club will host a card game day at the Tweed Heads South Community Hall which will be open to everyone. The club will also holding a barbeque on the day.

Council will be hosting its invitation only Tweed Shire Australia Day Awards and Citizenship Ceremony at the Murwillumbah Auditorium on Wednesday 26 January commencing at 9 am.

Upgrade will impact Council services

An upgrade of Council's IT will see a number of services unavailable from 1 pm Thursday 11 November to Tuesday 16 November.

During the outage, services for paying rates and other fees and charges, tracking development applications and enquiring about properties will be unavailable.

Council staff at the Murwillumbah and Tweed Heads Civic and Cultural Centres will be unable to process payments or support application lodgements and enquiries.

Before 11 November, please contact Council's Revenue team on 02 6670 2400 to discuss property settlements that will occur during the outage. The online services will be back on 16 November.

Council a finalist in national Climate Awards

Tweed Shire Council is a finalist in the Cities Power Partnership's fourth annual national Climate Awards, which recognise the work of local governments paving the way to a zero-carbon future.

Council is up for the Renewable Energy Achievement Award for developing and implementing its Renewable Energy Action Plan (REAP). The plan mapped out 3 phases of energy projects to reduce Council's corporate greenhouse gas emissions from grid electricity use by 25% by 2022 and 50% by 2025 from a 2016/2017 baseline.

Sustainability Program Leader Debbie Firestone said she was delighted to hear the announcement.

"Since adopting the plan Council has added 607kW solar generation capacity to 12 facilities, tripling Council's pre-REAP renewable energy generation capacity, reducing over 2,000 tonnes of greenhouse gas emissions and saving around \$650,000 a year in Council's electricity costs," Debbie said.

Award winners will be announced at a virtual award ceremony hosted by the ABC's Craig Reucassel at 4 pm on Wednesday 17 November.

Countdown begins across the Tweed for 4 December Council election

Plans for the NSW Local Government elections are in full swing with just over 4 weeks to go until the 4 December poll takes place across the state.

All 7 councillor positions at Tweed Shire Council will be contested at the poll, with voting compulsory for all registered voters.

Councillors elected in December will serve a reduced term after the 2020 election was postponed due to COVID-19. The future schedule of Council elections will not be impacted by this change and the subsequent election will proceed in September 2024.

Nominations for candidates in the election closes at noon on Wednesday 3 November, with the traditional draw to determine the order of candidates on the ballot paper to be conducted by the NSW Electoral Commission the following day.

Council's General Manager Troy Green said a suite of arrangements would be in place to ensure residents remain COVID-Safe when they come out to vote.

"Council is supporting the NSW Electoral Commission (NSWEC) to conduct a COVID-Safe election and ensure the health and safety of our voters, candidates and election staff," Mr Green said.

"QR code check-ins will be in place at all polling venues, larger venues have been booked to accommodate increased physical distancing spaces, face masks will be required, hand sanitiser will be available and increased cleaning arrangements employed.

"Voters will also be encouraged to bring their own pens into the polling stations or single-use pens will be handed out."

A suite of more flexible voting arrangements will also be in place in keeping with the COVID-Safe plan, with expanded pre-polling, iVote and postal voting options available.

Early voting or pre-polling will be available from Monday 22 November to Friday 3 December 2021. Any person enrolled to vote may vote by pre-poll.

Postal voting has also been expanded for this election. Applications for postal voting are open and close at 5 pm on Monday 29 November. The deadline for the receipt of postal votes has been extended to 6 pm on Friday 17 December but electors should still return their postal votes as soon as possible.

Similar iVote arrangements as exist for state elections will apply for this election. To check your eligibility for postal and iVote arrangements, visit the NSWEC website at elections.nsw.gov.au

The declaration of the poll is expected to occur between 21 and 23 December, 2021, with the new Council due to be sworn in on Tuesday 11 January 2022.


Thanks to everyone following Tweed Shire Council's Facebook page.
