Council and Griffith Uni offer First Nations traineeship

Aboriginal and Torres Strait Islander people can seize the opportunity to apply for a new Tweed Shire Council and Griffith University town planning career development program that offers financial and cultural support.

Applications are open from until 12 noon sharp on Friday 13 May 2022.

Council's Director Planning and Regulations Vincent Connell said the program aims to help increase the number of Aboriginal and Torres Strait Islander town planners locally and Australia-wide by serving as a model that other universities and councils could adopt.

"First Nations people are under-represented in town planning across the country," Mr Connell said.

"Councils are major employers of town planners in regions throughout Australia - if we work with universities and Aboriginal and Torres Strait Islander organisations, we can redress this situation.

"A more diverse profession is a stronger and more effective profession." The Aboriginal and Torres Strait Islander Town Planner Development Program, jointly run by Tweed Shire Council and Griffith University, provides First Nations people with the opportunity to receive financial and career support during their university studies.

One successful applicant will be selected to study the Bachelor of Urban Planning (Honours) at Griffith University's Gold Coast campus in Southport, with Griffith University providing a scholarship towards fees. For up to 4 years during their studies, they will work in a paid job the equivalent of one day a week for the Planning and Regulation Division

of Tweed Shire Council in Murwillumbah. Griffith University Director Cities Research Institute Paul Burton encouraged First Nations people who are interested in studying and forging a professional career in town planning to apply.

"From day one, you'll be immersed in the world of town planning, with your education and work experience equipping you with the knowledge, skills and experience to contribute to making our region a great place to live, work and play," Professor Burton said.

"Once they complete the program, we hope to put out another call for people to apply for the program."

Protecting our precious water supply

Extreme weather events such as floods and droughts can put our drinking water at risk. Now more than ever we need to improve our strategies and methods to protect our precious water supply.

Council has drafted a new Drought and Water Restrictions Policy based on experiences and learnings from the very significant 2019/2020 drought.

This Policy enables Council's Water and Wastewater Unit to make operational decisions in relation to the implementation, easing and

removal of water restrictions for the Tweed. We would like feedback from residents and businesses who are connected to the town water supply or use rainwater tanks topped up by a water carter from the town water supply.

Joint Regional Planning Panel expression of interest

Expression of interest open from 20 April to 11 May 2022 You're invited to apply to be part of Tweed Shire Council's Joint Regional Planning Panel.

The Joint Regional Planning Panel (JRPP) system was first established by the NSW Government in 2009. The planning panel responsible for matters concerning Tweed Shire is the Northern Regional Planning Panel (NRPP).

Planning panels:

- · determine regionally significant development applications (DAs), certain other DAs and s4.55(2) and s4.56 modification applications
- act as the Planning Proposal Authority (PPA) when directed
- · undertake rezoning reviews
- provide advice on other planning and development matters when requested
- determine site compatibility certificates under the State Environmental Planning Policy (Housing for Seniors or People with a Disability) 2004.

Tweed Shire Council nominees will be required by the NRPP for matters concerning Tweed Shire.

Panels consist of 5 members, with 3 of the members, including the chair, appointed by the Minister (State members) and 2 members nominated by the relevant Council (Council members).

Council is looking to appoint 2 permanent and 2 alternate members. In accordance with the Sydney District and Regional Planning Panels operational procedures (August 2020), at least one Council member must have expertise in one or more of the following areas: planning, architecture, heritage, the environment, urban design, land economics, traffic and transport, law, engineering or tourism.

All panel members must comply with the Planning Panels Code of Conduct. Property developers and real estate agents are not eligible to be members of a panel. Term of appointment for panel members will be 3 years. Council panel members will be paid a fee for services at an appropriate rate determined by Council

The candidates can make submissions which address how they meet the following criteria:

- Senior level experience in dealing with multiple stakeholders.
- High level communication skills.
- Capability to drive high profile outcomes in a credible and authoritative manner.
- High level analytical skills.
- · Knowledge and assessment of complex development and planning matters.


