Praise for Aboriginal Advisory Committee

A long-running Aboriginal advisory committee fostering communications between Tweed Shire Council and the indigenous community has been showcased as a glowing example for other NSW communities.

Representatives of the Tweed Shire Aboriginal Advisory Committee were guest speakers at the recent three-day NSW Local Government Aboriginal Network conference, hosted by Council in Tweed Heads, to highlight the group's achievements since it was established 20 years ago.

AAC representative Leweena Williams said the group had achieved a rare level of communication and understanding between the indigenous community and Tweed Shire Council staff and elected councillors, built on the committee's hard work, dedication and determination to have their voices heard.

Ms Williams said there were very few similar groups in NSW and many other indigenous communities had very little ongoing communication with their local councils.

The committe brings together delegates from a range of local Aboriginal organisations including land councils, aged and health care, education and Tweed Shire Council representatives.

Tweed Coast Road closure extended until end of the week

Council has extended the closure of Tweed Coast Road at Pottsville, between Boronia and Elanora avenues, to the end of this week (Friday 9 September) at the latest as the task to install new stormwater drainage pipes beneath the road slowed due to an unmapped sewer main blocking the way.

Traffic will continue to be diverted via Boronia and Elanora avenues before rejoining Tweed Coast Road north of the worksite. However, Council workers were working at the weekend to try to get the cross connection completed and the road reopened sooner.

Last week when the trench across the road was first opened, workers discovered an unmapped sewer main directly in the line of pipe-laying. To go through it, they had to shut down a nearby sewer pump station, empty the sewer main and cut a section out to allow the stormwater pipes through.

The sewer main then had to be re-routed above the stormwater and re-connected.

The main was the first of three sewer mains directly in the line of work, as well as electricity, Telstra and optic fibre connections. The multitude of services in the area has slowed the entire drainage upgrade since it began in late April.

The upgrade is required to provide a pathway for surface water to escape the low-lying area when it rains. In 2005, during a flood, the area effectively became a shallow dam. Since then, Council has been working to improve the drainage capacity. In 2010, it upgraded the drainage north of Rajungra Avenue and now it is working to complete the drainage upgrade south of Ranksia Avenue

Until Tweed Coast Road reopens, both the bus stop and Telstra public phone adjacent to the Pottsville North Caravan Park will be out of service. Buses will continue to pick up and drop off at a temporary stop north of Boronia Avenue for the duration of the road closure.

Both of these services will be restored when the road is reopened.



Study gains access to peak forum

Members of the Tweed Shire Equal Access Advisory Committee shared the stage with some of Australia's foremost experts of accessibility, when they were invited to speak at a major conference in Sydney last week.

The committee's recent audit of accessible toilets in the Tweed, dubbed the 'Dunny Run', brought many changes to assist people with impeded mobility, but it also earned an invitation to speak at the Universal Design Conference in Sydney on 30-31 August. Committee members Wendy Gilbert and Suzi Hudson, with pre-recorded video input by Una Cowdroy, outlined how their novel tour put Tweed Shire's 57 accessible toilet cubicles under rigorous scrutiny.

Ms Hudson, who has impaired vision, and Ms Cowdroy, who uses an electric wheelchair, got first-hand experience of the real accessibility of those facilities, which led by many improvements to meet Australian standards and added 31 toilets to the National Public Toilet Map.

Council is currently inviting nominations for this year's Tweed Shire Access and Inclusion Awards, recognising individuals and organisations for their efforts and achievements to make the Tweed more accessible and inclusive for everyone.

LOCAL HERITAGE ASSISTANCE GRANTS

Council opens applications for Local Heritage Assistance Grants 2016/2017

Local Heritage Assistance grants are now available for the Tweed Shire Council area. The purpose of the grant program is to encourage the conservation of heritage items.

Priority will be given to applications from owners of heritage items that are individually listed in the applicable Local Environmental Plan or items located within heritage conservation areas.

One grant of \$4000, two grants of \$3,000 and three grants of \$2000 are available to successful applicants on a dollar for dollar basis. This program is part funded by the NSW Office of Environment and Heritage.

The closing date for grant applications is **Wednesday 28 September 2016** at **4pm**.

Grants will not be offered if the work has taken place prior to the grant being offered or approved.
