Two numbers separated by a dash " - " denote minimum and maximum limits.

The 90% limit means at least 90% of readings in the twelve month licence period should be below this value, i.e up to 10% of readings can exceed this value and the licence may still be complied with (provided the maximum limit has not also been exceeded). When looking at less than twelve months of data it is possible that more than 10% of readings may exceed the 90% limit while not indicating a failure to comply with licence limits.
