Individuals who reside outside the Tweed Shire LGA, and employees or contractors of Tweed Shire Council or their immediate family members may compete, but they will not be eligible to win prizes.

#### **Entry**

To enter, eligible entrants must:

- Remove cane toads from the environment via hand-collection between Monday 12 December 2022 and Sunday 18 December 2022
- Count the cane toads they have collected and log their data on Watergum's online Toad Busting Database - https://watergum.org/toad-busting-database/
- There is no entry fee or purchase necessary to enter this competition.
- By entering this competition, the entrant is indicating his/her/their agreement to be bound by these terms and conditions.
- Multiple entries are allowed from the same person.
- The competition commences on Monday 12 December 2022 at 9:00AM and runs until Sunday 18
  December 2022 at 11:59PM. After this date and time, no further entries to the competition will be
  permitted.
- No responsibility can be accepted by Council for entries not received for whatever reason.
