## A7. Information Required under Section 68 of the Local Government Act 1993

1. A plan of the site drawn to scale, showing north point and the location of the sewage pumping station proposed to be installed on the premises, including the pipeline and boundary kit.
2. Specifications of the proposed sewage pumping station proposed to be installed including maximum flow rate.
3. Applications involving larger developments requiring hydraulic design eg: multi residential, commercial, industrial etc requires a copy of hydraulic drawings signed by a suitably qualified person showing the location of the pumping station and boundary kit. The number of persons serviced, or probable number of persons to serviced, on the premises.

If works outside of the property are required, detailed engineering plans by a Professional Engineer (Civil) will be required of the proposed pumping station system and connection to Councils existing sewerage system, in accordance with Development Design Specification D13.

### NOTES

1. Not all properties may connect to Council's existing sewerage scheme. Please ring Tweed Shire Council's Water and Wastewater Unit before filling out the application to confirm if a connection is allowable.
2. Council reserves the right to receive payment for application, installation fees or headworks charges (where applicable) prior to approval. The installation fee for Council owned and operated Sewer Ejection Pumping Station (where applicable) is \$14,800.
3. Works may be subject to inspections and final acceptance from Council.
4. Connections to Council Sewer Rising Mains will not be approved unless the lot is within an existing low pressure sewerage system.
5. Only plumbers and/or drainers licensed in NSW are permitted to carry out work and a plumber's Start Work Permit must also be obtained from Council prior to the commencement of any plumbing or drainage work. The owners are requested to insist upon the production of the Council final inspection report from the licensed plumber/drainers before making final payment to such licensed plumber/drainers.
6. If this ancillary application is part of your Development Application submission, you must provide this form with all supporting documentation with your Development Application when you upload your application to the NSW Planning Portal.
7. If this ancillary application is a stand-alone application (not related to a Development Application), this form with all supporting documentation must be completed and lodged via Council's online application page.
