

Tweed Sustainability Awards 2023 Free 2-night cabin stay at Tweed Holiday Parks

Competition terms and conditions

All nominees for the 2023 Tweed Sustainability Award will go in the draw to win a free 2-night cabin stay at Tweed Holiday Parks, valued at up to \$660.

Prize

The prize is a 2-night cabin stay at any Tweed Holiday Parks site during off-peak periods for a representative of one of the completed nominations for the 2023 Tweed Sustainability Awards (and up to 5 guests), up to the value of \$660, subject to availability.

Eligibility

The competition is open to all completed nominations for the 2023 Tweed Sustainability Awards. One representative from the winning entrant will be eligible to receive the prize. Nominations must be received by midnight 31 July 2023, and be complete with relevant information to address each of the fields in the online nomination form. Video entries are also eligible if they address all of the relevant information from the online nomination form. - Submit a completed 2023 Tweed Sustainability Awards nomination form via the Tweed Sustainability Awards webpage on the Tweed Shire Council website by midnight 31 July 2023.
- By entering this competition, the entrant is indicating his/her/their agreement to be bound by these terms and conditions.
- The competition commences on 5 June and the closing date of entry is midnight 31 July 2023. After this date and time, no further entries to the competition will be permitted.
- No responsibility can be accepted by Council for entries not received for whatever reason.
