### **BA1.Review Action List**

### 0623-1 Unauthorised dog on estate

Mayor Cherry provided an update on the unauthorised dog at Hovea Drive, noting Council has resolved to commence legal action in the NSW Supreme Court if the animal remains on the site.

The residents on the committee thanked Councillors for the follow up of this case and seeking clarification on assistance animals present in Koala Beach.

### 0221-1 Gutter guards

Jane confirmed that all gutter guards for storm water drains are in place. Location maps



distributed to committee. If any new locations are identified, send the details through for assessment by the consultant. Jane confirmed that individual pairs of birds are being monitored.

# 0821-1 Review of Companion Animals Policy

Kristian noted that Council is reviewing Council's Companion Animals Policy. Definitions and policy position of Council regarding assistance animals will be addressed in this policy.

Rangers can react to complaints and additional patrols organised at certain times of year.

## 0821-2 Working group to walk around site and consider areas for signage

Irene and Kirsty Wallace have started to put together a map. An observation is that wildlife awareness is not indicated until well into the estate.

Paula advised the letter she received from Transport for NSW confirmed that all roads within the Koala Beach estate are mapped and managed as 40km/h speed zones.

## 0322-1- Flagging addresses for animal registration in Koala Beach

Kristian confirmed that registration of an animal within the Koala Beach estate could be set to trigger an alert. The Rangers can then follow up as evidence is required. There isn't a process in place for refusing registration of animals in Koala Beach. Scott noted that there may be an opportunity to look at this issue on a statewide basis through the annual Local Government Ranger forum.

### Moved: Paula Searle Seconded: Yvonne Gardiner RECOMMENDATION:

That the Koala Beach Wildlife and Habitat Management Committee requests that Council seek legal advice on its ability to refuse registration of animals in Koala Beach Estate.

The committee voted all in favour.

Kristian emphasised that when community members were reporting details about domestic animals on the estate then the more details, location, times, the better. The Rangers can then schedule appropriate times to inspect those areas.



Discussion concerning the local real estate companies and their role in renting out properties ensued.

*Action:* Committee to write to local real estate agents to update them on animal policy in Koala Beach. Rosealie to provide addresses.

Cr Dennis commended Kristian for being pro-active. Council would normally have 8 Rangers but currently only have half this due to a range of situations.

Kristian encouraged the committee to pass on to Koala Beach residents to use Council's 'report a problem' tab on its website. This would result in their report being directed and actioned quicker and gives a reference number for follow up.

Kristian Pakula left the meeting at 1.45pm

### 0622-2. Vertebrate pest management and monitoring

Jane confirmed that there has been 1080 baiting, predominantly for foxes on private properties surrounding Koala Beach. This was completed on 15 September. Yvonne requested more information for her info pack and confirmed she will send what she has already to Jane and Scott.

#### 0623-1. Weed Control at Sugar Glider Drive storm water detention pond

Scott confirmed two different contractors used in that area. Staff have visited both areas and reported no concerns. Noel confirmed that the spraying was very erratic and requested a meeting with Scott.

Action: Scott to meet with Noel on site. Frances to organise meeting.

#### **BA.2.** Non-compliant fencing

Scott has started to compile the Koala Beach s88B covenants into a summarised format. Caterina requested full copies of all covenants.

Action: Scott to supply copies of covenants relevant to Koala Beach estate to Caterina.

### A1. Social

### A1.1 Bridge Mural Project

Noel confirmed that the design was completed after a few modifications last week. This was to avoid expansion joints on the bridge. The Sustainability & Environment Unit has been given the responsibility for the maintenance and graffiti removal of the bridge mural. 89 students have been involved in the production of the mural. Noel presented to the committee several slides showing the artwork in detail. The committee emphasised the timeframe was important as it needs to be completed before school finishes at the beginning of December. The committee congratulated Noel and Rosealie for the time and commitment put into the project.

Action: Jane to confirm dates. (Opening event on Thursday 30 November).



# A1.2 Signage Project

Noel, Paula and Rosealie have reviewed the sign design that was previously presented. The sign does not need to be a council branded sign as it is for the estate only. Council's signage and fabrication workshops are very skilled. Scott and Jane to establish communications with them. The restrictions include no steel poles and no non-frangible signs close to the road. The location is very important. It was decided to start with the actual design and then progress from there.

Action: Noel and Jane to liaise with Stephen regarding sign design.

Wording on the sign is very important. Any wording about the Aboriginal cultural values or Acknowledgement of Country is to be forwarded to Council's Aboriginal Advisory Committee (AAC) for consideration. The suggested wording "Caring for Wildlife on Bundjalung land" was agreed to be submitted for consideration.

**Action:** Jane to contact Tim Appo and request an opportunity for consideration of the proposed wording of the Koala Beach entry sign by the AAC.

## A2.1 Wildlife survey update

Irene confirmed that participation in the Glossy Black Cockatoo Count at Koala Beach went well.

## A2.2 Wildlife fatalities and traffic calming

High incidence of fatalities due to increased traffic through estate. The results of the motion put forward to Roads Unit was not satisfactory. A key concern out of the community survey was the high speed of vehicles and the estate being used as a through road. The committee would like to move forward with radar plans and extra speed humps near the school. Cr Cherry informed the committee that Council was acquiring 6 additional speed indicators.



**Action:** the working group submit a request to the Traffic Unit for traffic monitoring with a view to preparing a submission to the local traffic committee.

### GB3. Locked gate between the top of Marsupial Drive and at the end of Bottlebrush

Helene requested access to gate keys in the event of a catastrophic fire emergency so residents could vacate area. The committee discussed that this was beyond their role and referred Helene to write directly to Council on a community safety issue.

### **B4. Pottsville Master Plan consultation**

Locations listed as potential constructed bike tracks. The committee noted that they were concerned that the proposed potential location for a constructed bike track on Tweed Coast Road as it is a viable habitat for many different species.

Scott clarified that a full study on impacts on the proposed area of any constructed facility would be done prior to final decision.
