Bin lid switch begins as July launch approaches

Tweed households have begun receiving new lids on their green organic waste bins, to prepare for the 3 Bin System being introduced on 1 July to direct more waste away from landfill.

"The new lid includes a guide on what can go into the organics bin once the new service begins, advising people to put all food scraps and green garden waste into this bin," Council's Coordinator Waste, Rod Dawson, said.

The 3 Bin System will include a weekly organics collection service (green-lid bin) for all food scraps

and garden waste, one garbage (red-lid) bin, and one recycling (yellow-lid) bin. Urban residents in detached and duplex houses who have not received a new lid yet are reminded to put their green-lid bin on the curb on the day their green bin would usually be emptied – even if the bin is empty.

"If your lid is not changed on that day, put it out again on your next scheduled green bin day, a fortnight later. Solo Resource Recovery contractors changing the lids might not get to every household on the first occasion but will progressively get

Frech approach hits 2000 mark

Have you followed or liked Council on Facebook yet?

Julie-Anne Frech of Banora Point has, and when she clicked 'like' last Tuesday night, she became the 2000th person to do so.

So who is the person behind the 2000th click? Julie-Anne is 38, born locally, with an eight-year-old son, Xavier, and another bub on the way. A former teacher, she works as a private tutor and her partner is a fly-in, fly-out worker. A Facebook user of nine years, social media is an integral part of Julie-Anne's daily life. She also uses Facebook for her other business, Fun Mums Enterprise, where she "tries to inspire and add value to people on Facebook".

"I love keeping up with local news and it will be great to keep in touch through the Council's Facebook page. I also love the Tweed Link," she said.

Julie-Anne is a passionate recycler, so it was a video on the new 3 Bin System which sparked her interest in Council's Facebook page.

"A girlfriend shared the Council video and I thought that's fantastic, more people need to know about that," Julie-Anne said.

She has already had her green bin lid changed and received her kitchen caddy, roll of compostable liners and information on how to use the new system.

Julie-Anne composts and feeds kitchen scraps to her guinea pigs and the family's chooks, so she intends to use the new weekly green bin service just for clippings from her large garden. Time spent living in Canberra and Germany has made Julie-Anne very waste aware and she believes we all need to do more to reduce the amount of waste going to landfill.

"Other places are much more advanced than us, so it's fantastic to see the 3 Bin System coming in," she said.

them all done before 1 July," Mr Dawson said.

"Urban residents who don't already have a green bin will have one delivered to their properties as part of this changeover, as the organics green bin service becomes compulsory under the 3 Bin System. Free kitchen caddies for each household will also be delivered at this time, attached to the new lids."

Rural properties and multi-unit complexes with more than two residences will not be included in the 3 Bin System when it begins in July.

Convenient caddies for simple system

Free kitchen caddies are being delivered to urban Tweed households, to help them with the new organics green waste service starting on 1 July.

The caddies, to keep on or under the kitchen bench, will make it easy for urban residents to store their food scraps before putting them in their new green-lid bin. Every household that will receive the 3 Bin System will get a caddie, which will be attached to their new green bin lid when it is delivered during the next few weeks. An initial supply of compostable caddie liners will also be delivered to households at this time.

"It's important to note the supplied liners are biodegradable and will break down as the green waste is turned into compost," Council's Coordinator Waste, Rod Dawson, said.

"Normal plastic bags cannot be used in the caddies because they will contaminate the composting process.

"Compostable liners will be available for purchase and households can also use newspaper to line the caddies – or they can be used without a liner."

Rockface reinforced as Clothiers completed



Contractors secure strip drains to the rock wall, ahead of further steel reinforcement and shotcrete work, as work continues on Tumbulgum Road in Murwillumbah (above). Rockface drilling and nailing are now complete. Meanwhile, a realignment of the Clothiers Creek Road bend near Wallum Court is now complete, aside from revegetation work that will have no impact on traffic. The \$550,000 project has been funded by the Australian Government's Blackspot Program and is the first of two being undertaken in Tweed Shire this financial year. Council thanks motorists for their patience during this project.

Reconstruction of Tumbulgum blackspot

Council has started work at the southern intersection of Riverside Drive and Tweed Valley Way in Tumbulgum, to reconstruct the sheltered left turn lane and improve safety at this intersection.

The \$250,000 project is scheduled for five weeks and is funded by Roads and Maritime Services as part of the Blackspot Program.

There were eight injury crashes at this intersection over a five-year period. The Blackspot works will greatly assist motorists' vision as they approach, turn into or out of the intersection.

Once this intersection is completed, rehabilitation work will continue on Riverside Drive as part of Council's Road Infrastructure Program, at a cost of \$260,000. Weather permitting, this work will take another five weeks to complete. Road closures and a detour via the northern entrance to Riverside Drive will be in place for periods of time and delays can be expected.

Flood Recovery Centre update

More than 2000 people have accessed support services through the Murwillumbah Flood Recovery Centre over the past six weeks.

The Recovery Centre at Knox Park will be open until Friday 26 May with opening hours to be reviewed after that date based on community demand.

People requiring assistance are advised to visit the Recovery Centre or make contact as soon as possible

Once the Recovery Centre closes, a full range of help from agencies and support services will still be available and disaster welfare caseworkers will remain in the region visiting people and assisting with grants assessments.

Outdoor pool repairs begin

Refurbishment works begin this week on the outdoor pools at Tweed Regional Aquatic Centre (TRAC) Murwillumbah, after they were affected by the March floods.

Indoor facilities at the Murwillumbah complex were unaffected by the floods and have continued to operate uninterrupted.

However, the outdoor 50-metre pool and children's leisure pools were inundated by mud, damaging their filter.

Their refurbishment will include repairing the filter, before the outdoor pools are drained and recoated in preparation for reopening for summer.

In the meantime, learn-to-swim, fitness classes and other activities are continuing in the indoor pools.

2017 flood event – business damage summary

The scale of damage to local businesses in the 2017 flooding is only now being fully revealed.

More than 350 businesses, employing 1000 people, were affected - the majority in Murwillumbah and surrounding villages.

The Murwillumbah industrial area on the eastern side of the Tweed River comprises 126 Ha of industrial zoned land. The hardest hit area represents more than half (approx. 65 Ha) of the industrial area.

These businesses are primarily in the manufacturing, transport, wholesale,

construction and agricultural services. Some of the businesses that have sustained substantial flood damage provide essential services.

Most of the major damage occurred in South Murwillumbah, which houses a small retail precinct, most of the town's mechanical services and two industrial areas. Many of these essential businesses are not yet operational and some of them may fail completely without financial assistance.



ROAD WRAP

MyRoadsInfo was updated last Wednesday with the latest information on flood damage to our roads network. Please visit <u>http://northernrivers.</u> <u>myroadinfo.com.au/council.asp?id=9</u> for a comprehensive overview of both damage and repair status.

Flood repairs: Work this week will continue on slip repairs, bridge cleanups, silt removal and the removal and storage of damaged guardrail. Grading and heavy patching works have commenced and will continue on a number of roads.

Temporary traffic lights: Clothiers Creek Road, Hogans Road, Tyalgum Road (Rocky Cutting) and Tweed Valley Way (Blacks Drain) for flood repair works.

Normal program of works

Road closures: Major upgrade of Tumbulgum Road, between Sunnyside Lane and Old Ferry Road, Murwillumbah (six-month closure). Pedestrians and cyclists can still pass through section with care but all vehicular traffic will be diverted around the site.

Airfield Avenue, Murwillumbah, trucks to enter through Shoobridge Transport off Quarry Road.

Commercial Road, Murwillumbah, Boat Ramp Facility: North and middle access to the boat ramp will be closed. South access will remain open.

Mount Warning Road, road and culvert repair, limited access for local residents only.

Temporary traffic lights: Fraser Drive, between Vintage Lakes Drive and Acacia Street, Banora Point (sub-development work).
