Solar savings ahead

Council expects to save \$400,000 over the next 20 years, thanks to solar panels on the roofs of the Buchanan Street depot workshop and office building which will come on line in the next few weeks.

Local solar provider SAE is installing 240 photovoltaic panels on the workshop roof and 111 panels on the office building roof, equating to a 91kW to help Council reduce its power costs and pursue a more sustainable energy future.

The system will generate one-guarter of the energy used at the depot.

Council will pay for the \$81,000 system in savings in about four years.

The solar power generated by the panels is less intensive in greenhouse gas emissions, avoiding up to 200 tonnes of carbon emissions from gridbased power a year from the depot site alone.

The Caldera Environment Centre will stage the festival, funded and supported by Council, at Murwillumbah's Knox Park from 10am to 3pm.

Council will again have several activities at the festival, including a chance to find out more and ask questions about the 3 Bin System being introduced on 1 July for urban houses and duplexes. Learn about what will go in each of the bins, options for people with special needs for their bins, why the new system is being introduced and why it will save ratepayers money.

Find out about an extension to Council's Shower/Tapware Water Saving Rebate, which is being extended for another year and offers property owners refunds of up to \$100 when they buy new water-saving showerheads, tapwares, aerators and flow controllers.

Learn about the sewerage headaches being caused by 'flushable' wipes and why they are not actually suitable to flush down the toilet; blocking sewage pump stations, blocking pipes, causing

environmentallydamaging overflows and costing thousands of dollars each year.

Take part in a composting workshop or get tips on making your home more energy efficient, to save on power bills.

Discover the Seed Library available at the Murwillumbah Library, enabling residents to borrow free vegetable, fruit and flower seeds to plant in their gardens. The

library stall will also highlight the array of books and other resources about the environment and self-sufficiency available at each of the Tweed libraries.

This year's World Environment Day theme is Connecting People to Nature, inviting people to think about how they are part of nature and ultimately depend upon it.

Upgrade for safer Tumbulgum intersection

The southern road entry from Tweed Valley Way into the village of Tumbulgum has been closed for up to five weeks to allow the intersection to be made safer.

Motorists travelling to and from the village will need to use the northern entrance from Tweed Valley Way while works are ongoing. Signage has been placed on Tweed Valley Way advising of the side-road closure.

A sheltered left-turn slip lane will be constructed on Tweed Valley Way to allow motorists a safer exit from the 100kmh road into the village.

The \$250,000 upgrade is being funded by the federal government under its Blackspot Program. On completion of the intersection upgrade,

Council will resurface Riverside Drive at a cost of \$260,000.

Flood repairs continue

Mount Warning Road reopened to the public yesterday (Monday 29 May 2017) after being made safe following the March 30 floods, with the road to remainunder stop/go traffic control.

The National Park also reopened yesterday (information correct at time of publication).

Flood repair works on the road will continue for some time yet because only critical safety repairs completed to date. At some time, the road may need to be closed again as additional repair work is scheduled.

Motorists are advised to watch for traffic controllers on Mt Warning Road and other Tweed roads as flood repair works continue. In particular, they are urged to take extra caution even after light rain because many roadside environs are still saturated and prone to slippage and rock falls in the wet.

"The road you travel on today may not be the same road tomorrow," said Manager Infrastructure Delivery Tim Mackney. "Please expect the unexpected, especially after rain."

Council's road network sustained considerable damage in the floods, with more than 1500 individual road and bridge defects identified. To date, Council staff and contractors have completed around 350 of the simpler and most urgent repairs.

Council is engaging more contractors to help continue the flood restoration works as Council staff must begin to return to Council's normal program of construction works.

"Realistically, it will be 12 months before we have most of the damage fixed," Mr Mackney said. "Some more complicated or lowerpriority jobs may take up to three years before they can be scheduled and completed.

"We ask Tweed motorists to be patient as we work through this significant list."

Repairs are prioritised based on a number of factors, including safety.

FINGAL FOX TRAPPING PROGRAM

Fox trapping program at Fingal Head – 22 May to 19 June 2017

Tweed Shire Council (Council) is working with the Tweed Byron Local Aboriginal Land Council (TBLALC) to undertake a fox trapping program on TBLALC land on the Fingal Peninsula to protect native fauna.

Fox trapping (using soft-jaw traps) will begin in the hatched areas of the map below on 22 May 2017 and will continue until 19 June 2017 or until the foxes have been removed.

It is your responsibility to ensure that you keep your domestic pets out of these areas. If any domestic pets are caught in traps they will be taken to Tweed Shire Council Pound.

Trapping is being undertaken on private land only. Tracks into trapping areas have been signposted.

Flood repairs: Work this week will continue on Numinbah, Kyogle, Mt Warning and Zara/Limpinwood roads.

Temporary traffic lights: Clothiers Creek Road, Hogans Road, Tyalgum Road (Rocky Cutting) and Tweed Valley Way (Blacks Drain) for flood repair works.

Normal program of works

Road closures: Five-week closure to allow Blackspot Program upgrade of Tweed Valley Way and Riverside Drive intersection south of the village of Tumbulgum. Major upgrade of Tumbulgum Road, between Sunnyside Lane and Old Ferry Road, Murwillumbah (6-month closure).
