Community welcomes return of Nullum House

"Nullum House is more than just a building. It is a home to those who don't have one, a meal for those who are hungry, a family for people who have none, a shoulder to cry on when everything gets too much and to laugh when you thought you never would again. You have given us back more than just a building, you have given us a place to belong."

These were the heartfelt words from the community shared at the reopening of Nullum House last week following its repair and refurbishment in the wake of the March 2017 flood.

Nullum House was severely damaged in the flood and it was recommended that the building be demolished. But Council, with the backing of its tenant the not-for-profit Murwillumbah Community Centre Inc, rejected that recommendation and instead gutted and refurbished the building at a cost of \$100,000.

The building is now flood resilient and more vandal proof. The external blockwalls have been waterproofed to about one metre above ground level; steel security screens have been fitted and the eaves have been lined with Colorbond. On the inside, a more open-plan has been adopted with fewer internal walls, tiles have replaced carpets and a stainless steel kitchen and benches have replaced the timber fitout. Electrical circuits have been lifted above likely inundation levels.

Nullum House operates as a Social Inclusion Centre, providing a range of services to the homeless, lonely and struggling members of the community. It floods even in small events but this fitout will allow it to be hosed out and back in operation quickly after any future inundation.

Over the past 12 years, the Murwillumbah Community Centre has grown from a staff of two to now having 24 staff and volunteers providing lunch twice a week, shower and laundry services, counselling services, art and music therapy and connections to other support services. Three evenings a week the Combined Churches run a soup kitchen from Nullum House.

The Centre is open Monday to Thursday from 8.30am to 2.30pm and everyone is welcome.

Illegal connections found

Council is reminding anyone building a home that the first step to connecting to the town water supply is to apply to Council for that connection and a Council water meter.

Council charges a standard fee of \$510 to connect to its water supply for which Council puts in a standard 20mm connection and water meter and lodges all the appropriate documentation

The reminder to apply first comes after several illegal connections were found by water meter readers.

Connecting to the water supply without a Council water meter is illegal. Make sure that your builder and plumber understand this.

"We read every meter once a quarter so tend to discover illegal connections fairly quickly," Connections Engineer Elizabeth Seidl said.

"While an unauthorised connection to the town water supply equates to water theft, Council is equally concerned that all connections are standardised and compliant for the ongoing management and maintenance of our water supply.

"Any illegal connection may prove to be unsafe for our workers or pose a health risk to the connected household.

"While we do have the power under the Local Government Act to fine property owners and builders who illegally tap into our supply, this is a last resort. We prefer to encourage people to do the right thing," she said.

Council is carrying out audits of household bins to give personalised feedback so we can all improve our recycling habits.

Green bins are good, yellow bins could be better

Thank you to the Tweed community for your efforts to recycle garden waste and food scraps in the green organics bin, saving the equivalent of 43 collection truck loads each month from going into landfill.

Correct items placed in the green bin have also been very high. Previous independent audits have shown that contamination in Tweed's green bin is low compared to other services across the country - so well done and please keep this going.

What is of concern however is the high amount of incorrect items being placed in the yellow bin, particularly as China has stopped taking recycling imports from Australia and other countries around the world.

Previously, China was taking significant quantities of Australia's recycled plastic and paper. We need to now create more local markets for this recycled material and the most economical way for this to happen is for us all to ensure we are not contaminating the yellow bin with incorrect and dirty items (i.e. with food waste and liquids still in the containers).

In the coming months, Council will be undertaking audits of household bins to give personalised feedback which allows us all to improve our recycling practices and the contents of our yellow (and green bins). A Council officer may inspect your bin by way of a simple lift of the lid for a guick visual inspection of its contents. If your bin has been visited, an officer will leave a post card in your mail box confirming that we have been, and let you know how you are going.

Council's contractors will also be tagging bins that have incorrect items in them. If the incorrect item is identified before servicing, the bin will be left and the contractor will only return and service the bin once the incorrect items have been removed. If the incorrect item is identified during servicing, the camera inside the hopper of the truck will take a photo. Council will then contact and send information to residents to follow up.

You can help by knowing what goes in each bin and by keeping incorrect items out of your yellow and green bins. Too many incorrect items placed in a bin makes it more difficult to create a reusable quality product and may lead to whole loads having to be dumped into landfill. So please rinse out those bottles, cans and containers before putting them in the yellow bin and make sure food scraps and garden clippings are going into your

Please do not put plastic, biodegradable or degradable bags into the yellow or green bins as these contaminate both of these recyclable materials.

In the upcoming months, the councils in the Northern Rivers will also have a collaborative recycling campaign to further assist residents in all seven council areas. Keep an eye on the Tweed Link or follow Tweed Shire Council's Facebook page for updates.

Small Grants Program

Tweed farmers can apply for grants of up to \$4,000 to help fund on-ground projects through Council's new Sustainable Agriculture Small Grants Program.

These could include best practice farming methods that lead to improved water quality, soil health and biodiversity outcomes.

Council's Program Leader Sustainable Agriculture Eli Szandala said farmers around the globe are realising that through greater implementation of best practice land management, new innovative farming practices or even revival of old (pre-industrial) farming methods, they can significantly improve the quality of their land.

"This in turn leads to more viable and productive farms and associated benefits for the environment and the wider community," Mr Szandala said.

"Unfortunately however, most of our farmers are doing it tough, which makes starting new projects difficult. These grants can provide the incentive for our food producers to start a small project which can ultimately lead to big changes over time.

"We've already heard about some fantastic project ideas and encourage all producers in the Tweed to consider their opportunities by applying for a grant," he said.

The new program complements Council's existing River Health Grants and Biodiversity Grants Programs and provides opportunities to work closely with our farmers to achieve positive environmental and community outcomes.

Applications close at 4pm on Friday 26 October 2018 and successful projects are expected to have grant funding expended by 30 June 2019.

An amended development application has been lodged by Coastplan Consulting seeking development consent for demolition of existing dwelling and construction of a caravan park in 5 4 stages; Stage 1: 15 short term 8 short term (caravan) and 54 52 long term sites, eommunity centre, swimming-pool, amenities, men's shed, managers dwelling and on site detention ponds, the supporting buildings and infrastructure, including the community centre, swimming pool, amenities building, men's shed, gardener's shed and community garden, the Managers Residence, the main access road to the site from Sanderson Place, associated on site landscaping, sewer pump station and sewage treatment plant compound, and the new groundwater bore; Stage 2: 32 52 long term sites; Stage 3: 28 32 long term sites; Stage 4: 32 long term sites; at Lot 2 DP 803636; No. 355 Tomewin Road, Dungay.

Tweed Shire Council originally refused the application and the applicant is challenging that refusal in the NSW Land & Environment Court who will ultimately determine the proposed amended application.

Any person may, during the above period, make a written submission to the General Manager of Council. It should also be noted that Council has adopted a policy whereby, on request, any submission including identifying particulars will be made public. Council will give consideration to the 'Public Interest' and requests for confidentiality by submitters in determining access to submission letters. However, the provisions of the *Government Information (Public Access) Act 2009* – GIPAA may result in confidential submissions being released to an applicant.

Any submission objecting to the proposed development must state the ground upon which such objection is made.

Subscribe for latest

At the time of going to press on Monday, sand was still blocking the mouth of Mooball Creek at Pottsville, stopping tidal flow.

Swimming is not advisable in this creek this week nor in any coastal creek following heavy rain, due to urban and rural run-off.

Council has been monitoring the situation closely and is seeking the necessary State Government approvals to take action to clear the blockage with machinery.

At the time of going to press, there was concern that if not done properly and under the right conditions, opening up the creek with machinery could make matters worse. Good quality water drained out of the lower estuary would be replaced by lower quality water presently sitting in the upper estuary and cane drains of Wooyung. This water is lower in dissolved oxygen and has a lower pH, and potentially higher bacteria levels.
