

Tumbulgum flood project wins national award

NRMA Insurance in partnership with Floodplain Management Australia (FMA) has announced the Bureau of Meteorology, Tweed Shire Council, Tumbulgum Community Association, NSW SES and NSW Office of Environment and Heritage as the winner of its Flood Risk Management Project of the Year Award.

The joint project developed and implemented a new flood warning service and response plan for Tumbulgum, which is located at the confluence of the Tweed and Rous rivers.

The new flood warning service enables the community to enact their own flood evacuation plans and to leave the area before evacuation routes are impassable. The project included a cooperative and risk focused approach across all levels of government and the community.

President of Tumbulgum Community Association Jenny Kidd said that residents had been pleased to participate in the project.

"The information from the project has assisted in the development of our community plan and been shared with village residents to inform their decision-making in the next flood event," she said.

Alex Clifton, Senior Flood Hydrologist at the Bureau of Meteorology said the project recognised both the community's vulnerability to flooding and their unique circumstances.

"This service helps people to enact their own evacuation and protection measures before the onset of flooding, greatly reducing the risk to life, homes and property.

"It's not just Tumbulgum that will benefit from this, being able to identify what the flood waters are doing earlier, combined with the development of local response plans that can be rolled out to other local communities, means that there are benefits to towns and villages all across the Northern Rivers region," he said.

As the winner of the Excellence Award, the project team will receive \$10,000 to continue this important work.

Nathan Bewes Park officially opened

Last Friday a ceremony was held in Murwillumbah to open a park in honour of Private Nathan Bewes.

Private Bewes lost his life serving in Afghanistan in July 2010 when he was just 23 years old.

The ceremony to officially open Nathan Bewes Park was attended by more than 70 people including his parents, Gary and Kaye, friends and comrades as well as other community members.

The park adjoins the Mount St Patrick College grounds on Queensland Road, a school Nathan attended between 1992 and 2004 and is opposite the barracks where he trained as a cadet in the Murwillumbah 225 Australian Army Cadet Unit.

As part of the ceremony memorial signage of Nathan's life was unveiled in the park which includes these words said by Nathan's commander at his funeral, "He was not your average 23 year old Australian, he was a modern day ANZAC warrior, he never missed a patrol, he would go to the end of the earth for his mates and would not expect anything in return.'

Local community groups receive funding boost

A community garden project, support for new mums and a youth service program are among the initiatives to receive a share of \$29,600 in funding through Council's Community Sponsorship Policy for 2019.

The aim of the Community Sponsorship Policy is to provide financial assistance by way of a sponsorship agreement to local community groups and organisations. These funds are for activities and projects that benefit the health and wellbeing of Tweed Shire residents.

One of the recipients was Victory House, a residential program providing recovery for people overcoming drug or alcohol addiction or other life-controlling issues.

David Nahi, Director and Founder of Victory House said, "Part of the recovery for residents of our program involves 'giving back', where residents give back by helping elderly people with gardening, giving out groceries to families in need, assisting other charities and churches, moving furniture and removing graffiti.

"This funding will enable us to buy a new vehicle to help more people in the community through our giving back program and we are very grateful for the funds," he said.

Kingscliff park named as the best in NSW

Rowan Robinson Park in Kingscliff has been named Park of the Year 2019 for New South Wales and the Australian Capital Territory at the recently held awards night at the Canberra Arboretum.

The park will now represent New South Wales and the Australian Capital Territory at the National Park of the Year Awards in Perth at the end of October.

Opened just over a year ago, Rowan Robinson Park was the centrepiece of the \$22 million project to revitalise Kingscliff foreshore.

The award comes just weeks after another key element of the project, the restoration of Kingscliff Community Hall and buildings, was named joint winner in the Conservation Built Heritage category at the National Trust Awards (NSW).

The park was named in honour of Rowan Robinson a popular Kingscliff High School student and local Surf Life Saver who lost his life serving in Afghanistan in June 2011.

The idea to name the park in his memory was put forward by a number of people in the community. A plaque is located close to the cenotaph with a brief description of Rowan's life.

Other contributions from residents include a mosaic wall which was decorated with tiles created by Kingscliff Primary School, Murwillumbah artist Tony Lawrence painted a mural on the table tennis table and residents suggested quotes to be engraved in the some of the pavers.

Council also worked with local artists to add a series of postcard images on the park shelters showcasing what was unique about Kingscliff.

New cat mapping tool

Have you ever wondered how far your beloved cat travels, and where it goes? Are they out-and-about exploring the neighbourhood, or just lazing away nearby?

On the Tweed Coast, remote monitoring cameras are being used in natural bushland areas to find out what types of animals are present. As well as images of native wildlife, these cameras have recorded roaming pet cats when they are out at night and during the day. Feral animals, such as foxes and wild cats have also been recorded.

Council has now developed an interactive 'Cats on Camera' mapping tool from three locations on the coast. These maps show images from the remote cameras of roaming pet cats, the threats they face and the native wildlife that lives there.

Roaming pet cats face many dangers including dogs, foxes, snakes, ticks, busy roads, other cats and diseases like feline AIDS. Pet cats can also attack native wildlife when they are roaming. The tool aims to help cat owners make informed decisions about the management of their pet cat.

Since opening, the park has become the main gathering area for large events such as music concerts, Anzac Day parades and major Surf Life Saving events.

Landscape Architect Ian Bentley led the design of the park for Council, "Before Rowan Robinson Park there wasn't a place in Kingscliff for large gatherings, to watch bands, to accommodate 30 kids at a birthday party or a place to just hang out and watch others pass you by. With its completion the community now have that heart, that central location that connects coffee shops and beach users, walkers and birthday party goers."

The Kingscliff Foreshore Revitalisation project has been shortlisted in the upcoming NSW Local Government Excellence Awards.

maps also use local surveys and known information about roaming pet cat behaviour.

Research has shown that pet cats really do roam. Using data collected from Council's remote cameras, it is estimated that one cat "Snowy", roamed over an area the size of 1,167 ha. That's equal to the size of 800 football fields all joined together!

First aid for motorcyclists

Motorcyclists often ride together and are the first on the scene when a rider comes down.

Knowing what to do in those first few minutes after a crash could save your mate's life or reduce their level of injury.

Council is providing two free Motorcycle First Aid courses next month and urges all local riders to participate to get the skills needed to provide that critical first aid.

Both courses are for licensed riders and run for seven hours from 9am to 4pm. They include the basic first aid course and then the specialist skills required for a motorbike crash, such as how to remove the helmet of a crashed rider. They also will help riders identify hazards and promote the safety benefits of wearing protective clothing.

Those who successfully complete the course will be awarded a Statement of Attainment Providing First Aid.

The first course will be held on Saturday 15 June in Murwillumbah. The second course will be held on Sunday 23 June in Banora Point.

The courses are provided as part of the Local Government Road Safety Program, which aims to reduce road trauma. Both courses will be delivered by Pulsestart Training Solutions and lunch will be provided.

Council may require manhole access on your property

Sewer manhole inspections are currently being carried out across the Tweed, some of which fall on private property.

Wherever possible, Council officers will seek your permission before entering your property. If you are not present at the time of inspection the officers will leave a letter informing you that an inspection was completed. The officers will carry Council identification.

These inspections are an important part of Council's ongoing maintenance of the sewerage system to protect public health and the environment. Council assesses the condition of sewer manholes to ensure they are accessible and to identify if further maintenance is required.

Residents are responsible for ensuring that access is available to manholes on their property. If you have a manhole on your property, please don't bury it or put any large object over it.

If a manhole on your property is not accessible, Council may ask you to make it accessible or do work on your behalf. In some instances, excavation may be required. For example, if a garden bed has been built over the manhole, Council may ask the property owner to restore access.

Under the *Local Government Act 1993*, Council has the right to enter private property to access sewer infrastructure.
