# An inclusive playspace for the Tweed moves closer

Tweed Shire Council and Variety – the Children's Charity recently announced a partnership to construct a state-of-the-art inclusive playspace at Goorimahbah – Place of Stories, Jack Evans Boat Harbour in Tweed Heads.

Tweed Shire Council is one of four Councils (along with Liverpool City Council, Shoalhaven City Council and Newcastle City Council) to receive the Variety Livvi's Place 2019 Design Grant to support the development of these inclusive playspaces.

Variety has successfully partnered with other local governments to deliver similar playspaces in Bankstown and Taree. These facilities are thriving family destinations where all children are welcome and included.

# Save water now as water levels continue to drop!

The drought is beginning to bite harder in the Tweed, with Level 4 water restrictions in place in Tyalgum from last Sunday (24 November).

The restrictions are aimed at reducing use to 126 litres per person per day and apply to all residential and business water customers.

For users of the Tyalgum water supply this means no use of water outdoors, including:

- · no watering of lawns and gardens
- no washing of driveways, windows, cars, boats
- no topping up of swimming pools or spas (only allowed with prior approval from Council to avoid structural damage)
- no topping up of ponds and aquariums (except to keep fish alive) no use of water toys or outdoor showers
- no hoses to be used for pet washing, just a bucket.

and visitors will be given the chance to be involved in shaping the design of the playspace, with public consultation to begin once a designer has been engaged.

Variety will also support the development of a fundraising initiative for the project, working with local businesses and the NSW Government to financially support the inclusive playspace in reaching its full potential.

The project provides an opportunity to create an inclusive playspace in the heart of Tweed Heads that will engage all children and their families and carers in the act of play.

Pending successful grant applications, work at the site is proposed to begin in the 2020-2021 financial year.

Meanwhile, Level 1 water restrictions are looming for all Tweed residents on town water and Council is appealing to people to

minimise use Water use last week across the Tweed was up - 193 litres per person per day (see above) - against the target of 160 litres per person per day. This means we all need to save 33 litres of water per day.

The easiest way to do this is to take shorter showers, check for leaks and ensure any rainwater tank is not being topped up by the town water supply.

There are free signs and stickers available at Council offices and local libraries for posting in front vards and on letterboxes in support of the water saving effort and to drive an improved community response to this serious issue. Free shower timers are also available.

# **Community Vision** concepts for Fingal Head

Member of the Fingal Head community are encouraged to have their say on four Community Vision concepts, as part of the second stage of community consultations designed to help draft the Fingal Head Locality Plan.

The Locality Plan will define the community's shared vision for the future and will create a set of planning goals and actions that will help to achieve that vision, by protecting the valued local character of Fingal Head.

The concepts were prepared using feedback captured at Community Conversations in May 2019 and consultations as part of the Fingal Head Building Height Review.

"These concepts are examples of what the final Community Vision for Fingal Head could look like, and the types of things it could say," Director Planning and Regulation Vince Connell said.

"To ensure we base the Fingal Head Locality Plan on a vision that is shared by the community, we want to understand what the community likes or doesn't like about each concept. Does one Community Vision concept resonate more than another?"

Council will use the community feedback to narrow down the four Community Vision concepts into two improved options that will be presented back to the community to vote on.

The winning concept will then become the main guide for Council and the community when deciding which planning goals and actions should be included in the Fingal Head Locality Plan.

# **Recognition for dedication** to Tweed's coastline

Council's Unit Coordinator - Sustainability & Environment Jane Lofthouse was awarded the Lifetime Achievement Award at the 28th Annual NSW Coastal Conference held in Terrigal this month. The award recognised Jane's involvement in coastal management for 25 years at the local and state level.

Tweed Shire Council was the first council in NSW to gazette a Coastal Zone Management Plan and one of the first to adopt a development control plan to address coastal erosion risk along the open coast.

Certification of the Kingscliff-Dreamtime Beach Coastal Zone Management Plan provided the legislative framework for Council to construct the protective seawalls at Kingscliff Beach, enabling the development of Rowan Robinson Park and the upgrade of the Kingscliff Beach Holiday Park.

Jane is currently appointed to the NSW Coastal Council, and previously the NSW Coastal Panel since 2011, providing a local government perspective on this Ministerial advisory board.
