Community hall in Pottsville gets a brand new floor

It's been a long time since its opening in 1985 but now the Pottsville Beach Community Hall has something new to brag about - a shiny new floor.

To ensure the Tweed grows in an environmentally, socially and economically responsible way, the project was recently completed by local contractors from Kingscliff and included removal of the existing floor and the supply, laying and treatment of a new stringybark hardwood floor.

The sustainably sourced timber was purchased through a local supplier and the old floor will be recycled and re-used, following through with Council's 'zero waste' commitment.

The partnership between Tweed Shire Council and Pottsville Beach

Community Hall Inc. to repair the wooden floor comes at a perfect time for this growing community.

To pay for the refurbishment, Council was successful in gaining \$30,000 from the NSW Government's 2018–19 Crown Reserves Improvement Fund Program (CRIFP) to the Tweed Coast Reserve Land Manager towards 50 per cent of the cost of replacing the wooden floor.

As a requirement of the grant, \$15,000 funding was contributed from Council's Community Facilities Maintenance budget and \$15,000 was contributed by Pottsville Beach Community Hall Inc.

Environmental projects honoured in State awards

Tweed Shire Council has won two Local Government NSW. **Excellence in the Environment Awards for its Biodiversity and** Habitat Management Development Control Plan and 'Tackling Mosquitoes Together' project. The Awards recognise outstanding achievements by local government in managing and protecting the environment.

Council was the division winner as well as the overall category winner for its recently adopted Biodiversity and Habitat Management Development Control Plan. The Plan provides clear guidance on the types of habitat that should be retained and the management of ongoing impacts associated with development.

Tweed Shire Council's project, 'Tackling Mosquitoes Together' was the Overall Category Winner of the Environmental Health Management Award.

The project establishes a plan on what we need to do if a new mosquito species (like the Asian Tiger Mosquito that can spread Dengue fever) turned up in Northern NSW.

'Tackling Mosquitoes Together' mobilised all seven of NSW Northern River councils and the Local NSW Public Health Unit who worked together to establish an effective rapid response network, a two-day, house-to-house inspection trial and a citizen science survey. An education package was also developed and tested for impact.

Building Resilience to Climate Change is a partnership between LGNSW and the NSW Office of Environment and Heritage that aims to address identified climate change risks and vulnerabilities facing NSW councils.

Save water now to delay restrictions

Water restrictions start

Level 2 Water Restrictions come into effect for Tweed residents from Friday, 13 December.

The level of Clarrie Hall Dam is at 77 per cent and falling 1.8 per cent a week against an original estimate of one per cent a week.

Tyalgum customers remain on the most severe level of water restrictions at Level 4.

Council will launch its Save Water Now education campaign on Friday to raise awareness of what Level 2 water restrictions mean and how best to save water.

This week's average water use figure of 194 litres per person per day shows that everyone has to find ways to save 50 litres of water a day, that's five household plastic buckets; or, for a family of four, a standard bathtub filled to the brim.

The easiest way to save water is to reduce your outdoor water use, have shorter showers, fix any leaks and dripping taps and make sure your rainwater tank top-up system is working correctly and not being topped up by the town water supply unnecessarily.

is a fantastic outcome for the local osprey population. "The pole is located on the edge of Terranora Creek with commanding views of the estuary where their fish prey will be easy to spot," Mr Bloor said.

"Unfortunately due to loss of one of their key habitat requirements – that is, large old trees close to waterways - ospreys in the Tweed now rely on artificial nests to breed and raise their young.

Council inspects and maintains artificial osprey nests across the Tweed and this new nesting cradle is the fourth to be installed with two others located at Kingscliff, one at Les Burger Sports Field in Cabarita, and a roosting pole located at Black Rocks, Pottsville.

Tweed Heads cultural plaza re-opening

The \$1.2 million Tweed Heads Civic and Cultural Centre redevelopment is nearing completion, with only a few finishing touches to do on the plaza and café and an official opening planned for early 2020.

The upgraded facility includes an outdoor plaza with a direct pathway for easier access to the library and auditorium and Council's Tweed Heads Administration Office, contemporary landscaping, an improved drop-off area, accessible parking, better lighting and a more accessible after-hours library book return.

Access to the library and auditorium is available from the front entrances again and the public can use the front car park off Brett Street.

Council's Manager Community and Cultural Services Robyn Grigg said the upgrade has provided an attractive, accessible and functional meeting place

"It looks modern and refreshed and we hope the community will enjoy the new space to meet for coffee, attend a show at the auditorium and enjoy all that the library has on offer," Ms Grigg said.

The new social enterprise café in the plaza is almost complete and will open to the public in early 2020, serving barista coffee, tea and snacks. The project is jointly funded by the Australian Government's Building
