## **Tweed Shire Council cultural facilities closed**

To reduce the potential spread of coronavirus to vulnerable community members, Council has closed its cultural facilities effective from Tuesday 17 March.

This includes libraries, gallery and museum facilities.

The facilities will be closed for two weeks, with the closure reviewed on a week-by-week basis after that. All associated events and public programs during this period will not be held. The closures affect:

- · Richmond-Tweed Regional Library branches at Tweed Heads,
- Kingscliff and Murwillumbah
- Tweed Regional Gallery & Margaret Olley Art Centre and Gallery DownTown in Murwillumbah

• Tweed Regional Museum at Murwillumbah, Tweed Heads and Uki. Council's Director Sustainable Communities and Environment Tracev Stinson said Council had a duty of care to its cultural facility patrons and the community.

## Council takes steps on coronavirus for community

As the global situation with coronavirus (COVID-19) continues to develop, Tweed Shire Council is taking all necessary precautions to keep the community and staff safe.

Council is closely following advice from federal and state health authorities. To ensure that Council is prepared and able to respond quickly to the progress of the virus within the workplace and the local community, Council has established a planning group with members from across the organisation, which first met last Monday. Apart from measures to keep Council staff safe, Council has taken a

Council is inviting residents and community groups to register their interest in commenting on the Environmental Impact Statement (EIS) for the raising of Clarrie Hall Dam.

Consultants Eco Logical Australia began work in December 2019 to prepare the EIS for the proposed raising of Clarrie Hall Dam. They are expected to finalise that document to go on public exhibition at the end of this year.

The EIS must be exhibited for 28 days, with public submissions to be made within that period.

"This project has been classified as a state-significant infrastructure project for NSW and is one of Council's highest priorities." Manger Water and Wastewater - Business and Assets Anthony Burnham said.

"We can expect the EIS document to be weighty in both content and size so we want to ensure that all residents and community groups interested in interrogating that document and commenting on it have the full opportunity to do so."

## Well done – we cleaned up!

Three tonnes of waste was collected by Tweed Shire Council for Clean-Up Australia Day this year - a great effort by the community.

A total of 34 sites were registered with Council including three youth, 17 school, 14 community and one business clean-up site. There were also three dive sites which cleaned up the Tweed River.

Victoria Wells from Brisbane Dive Academy who cleaned up the Tweed River said their team filled their bag five times.

"The most common things we found were glass bottles and discarded fishing lines and hooks," Ms Wells said.

"Some of the weirder objects we found were stainless steel dog bowls (how this ended up in the river I have no idea), big shards of glass, a big sheet of vinyl and lots of towels," she said.

Another big contributor was the team from Big Trev Watersports Tweed Heads, who celebrated 30 years of Clean Up Australia Day at Jack Evans Boat Harbour. Well done to everyone for helping to keep the Tweed beautiful.

Collectively Australia removed 15.5 thousand tonnes of rubbish from parks, beaches, bushland, suburban streets and waterways right across Australia over Clean Up Australia Day.



## **Council relaxes delivery hours**

Supermarket operators in the Tweed will be able to receive delivery of goods outside their normal regulated hours for a period due to supply issues related to the coronavirus.

Council's Director Planning and Regulation Vince Connell said Council had received a request from a supermarket operator for a twoweek moratorium on the enforcement of delivery curfews in the Tweed local government area.

"Supermarkets have told us pressure is being placed on supermarkets' supply chain, especially on key items such as toilet

paper and antibacterial products," Mr Connell said. "They are keen to ensure customers understand that there is no

need to stockpile and they can assist this by keeping shelves in stores well stocked.

"After consulting with Councillors, we have agreed to assist by not taking compliance action against supermarkets in the Tweed receiving deliveries of goods outside of their normal delivery hours for the period 13 March to 27 March 2020.

Council apologises to residents for any inconvenience or additional noise during this time.

One or two meetings will be held during preparation of the EIS and during public exhibition, depending on the level of community interest.

All submissions must be responded to formally in a 'Response to EIS Submissions Report', which goes with the EIS document to the Minister to determine whether the project can proceed. That determination, plus any conditions placed on the project by the Minister, then returns to Council for a decision.

## DA lodged for temporary pound

A development application has been lodged with Council for a temporary Pound and Rehoming Centre on leased private premises at Dulguigan.

It is the next step in a process which will lead to the building of a new permanent Pound and Rehoming Centre in 2022.

The former pound at Stotts Creek closed on 25 September last year to allow for the expansion of the Waste and Resource Recovery Centre. Since that time, impounded animals have been cared for at a privatelyowned boarding kennel at Tygalgah which has not been accessible to the public.

Council's Director Planning and Regulation Vince Connell said the temporary arrangements had been a success and there was a smooth transition between the Stotts Creek and Tygalgah facilities.

"We have been very pleased with the standard of care provided at Tyglagah, which has maintained high standards of service and levels of care for impounded animals," Mr Connell said.

"While there has been a delay of a few months in our original timeline to move to the next temporary facility at Dulguigan, the impounded animals are in safe hands at Tygalgah.

"Once we move to Dulguigan, which we anticipate to be in the middle of this year, the public will be able to visit the facility to retrieve impounded animals and view animals for potential adoption," he said.

"Council works closely with the volunteers from Friends of the Pound to re-home the dogs and cats in the Tweed area. If you are looking to buy a new pet for your family we strongly encourage you visit their website friendsofthepound.com/adopt and consider adopting," he said.

## Scenic Drive closure delayed

Works on Scenic Drive, near Gull Place, at Tweed Heads West have been delayed due to rain and contractor availability.

The works to repair a landslip were to have started on Monday 23 March but will now start on Tuesday 14 April.

Rescheduling the works to the school holidays may also help reduce traffic congestion on this busy arterial road, which offers no practical detour options.

One lane of Scenic Drive will be closed 24/7 for two weeks to repair a landslip above. While the closure will only be for about 30 metres, the

closed lane will be used as a site compound. Stop slow flagmen will manage the traffic during work hours, with

traffic lights in place after hours. If possible, motorists are urged to travel via Bilambil Road and

Terranora Road to access the Pacific Motorway, Tweed Heads and Gold Coast areas. If using Scenic Drive, please plan your trip and leave early to avoid the stress of likely delays.
