First ever outbreak of invasive weed in the Northern Rivers

An outbreak of the highly invasive Parthenium weed has been detected on a rural property in the Tweed by Rous County Council Weed Biosecurity Officers.

It is the first time the weed has been found in the Northern Rivers region and was discovered when officers were carrying out targeted work on properties identified as high risk of Parthenium weed incursion.

The weed (Parthenium hysterophorus), a native of the Caribbean region, is highly invasive to the natural and agricultural environment and is known to cause severe health reactions in humans and livestock.

Once the property owner was made aware of the Parthenium, it was reported immediately and biosecurity officers were able to identify the weed and began manually removing all flowering plants and treating

Free water booklets for all primary school libraries

Tweed Shire Council is giving away four booklets to every primary school library in the Tweed this week to help teach the younger generation how water works and how precious it is.

The move is part of Council's sponsorship of the first ever national Water Night to be held across Australia on Thursday 22 October 2020. All Tweed residents are urged to register for Water Night to learn just how addicted they are to using their taps.

The water awareness initiative is being conducted by not-for-profit water efficiency experts Smart Approved WaterMark.

The challenge is to stop reaching for the tap and instead use just one 10-litre bucket of water for all household needs between 5pm and 5am (with the exception of drinking water, hand washing for COVID-care, religious purposes and flush if you must).

Council locks in wind and solar energy agreement of electricity-related carbon emissions by 2022 and a 50 per cent

Tweed Shire Council has started a 10-year Power Purchase Agreement with retailer Flow Power to supply electricity to Council's largest sites.

The agreement includes buying more than half of Council's electricity from NSW wind and solar farms.

The Power Purchase Agreement sources energy from Sapphire Wind Farm, near Glenn Innes, and the new Bomen Solar Farm, near Wagga Wagga.

Council recently adopted a new Climate Change Policy which sets a goal for the organisation to achieve net zero carbon emissions by 2030.

To achieve this goal, a Renewable Energy Action Plan has been developed. Under this plan, Council has completed a broad range of energy efficiency works and has installed more than 800kW of solar photovoltaic (PV) systems across Council facilities.

Council plans to install a further 750kW of solar PV at more sites this financial year.

These local projects, combined with Council's intention to progressively increase its supply of renewable energy, will enable Council to achieve its interim targets of a 25 per cent reduction

Council meetings continue to be livestreamed

Council has resolved to adopt a 'hybrid' model for Council meetings, starting from 22 October 2020.

Since April 2020, Council meetings have been held virtually and livestreamed, due to COVID-19 restrictions and concerns. Under the hybrid model, Councillors have the option of attending the

meeting in person or remotely. The physical aspects of Council and Planning Committee meetings will be held in the Harvard Room at the Tweed Heads Administration Office. Members of the public will continue to be excluded from attending meetings in person because of COVID-19 restrictions.

However, the meetings will continue to be livestreamed. Meetings will now begin at 5.30pm, following the Public Forum which will commence at 4.30pm for the remainder of the Council term (until elections are held on 4 September 2021).

In the case of a Public Forum, where a member of the public is unable to attend via audio-visual means, the option will be given for the individual to attend in person for the Public Forum only.

Giving young poets confidence in themselves and the courage to express their thoughts and views in front of an audience is one of the rewards of mentoring for Anna Avocado.

Anna, the 2019 Queensland Slam Poetry champion, is one of several mentors working with entrants in this year's Youth Poetry Slam, hosted by Poets Out Loud and supported by Tweed Shire Council

The slam is open to young poets in the Northern Rivers aged 12 to 24 and this year has attracted 27 entrants from the Tweed as well as entrants from Byron and Lismore local government areas

- **Expression of interest clean fill**

Council is calling for expressions of interest from landowners willing to accept clean fill from its construction projects.

Council would deliver the fill free of charge to the property if the trip is shorter than that to a Council disposal facility. If the trip is longer, the property owner would be charged a gap fee based on mileage. Properties suited to accepting fill must be able to be accessed by a tandem truck. In wet weather, fill can only be delivered to properties with all-weather access.

If Council accepts a property as suitable, it will add the property to a database and contact the applicant when clean fill becomes available from a nearby worksite.

For flood's sake



In the Tweed, if 300mm of rain falls within 24 hours, expect significant flooding.

Short bursts of much less rain can bring flash floods, particularly in the Hinterland and low-lying residential areas of Tweed Heads.

Then, in Tweed Heads, Chinderah and the Coastal Villages, the worst flood will come when there is significant rain coupled with an ocean storm surge or king tide.

- So, what's your flood trigger to:
- lift your property from any under-storey?
- move your vehicle?
- pick the kids up from school?
- leave?

A survey of 800 central Murwillumbah residents in early 2018 found that very few of them understood their flood risk or would respond quickly to an order to evacuate or evacuate at all.

In March 2017, had it rained for a few more hours, the Murwillumbah CBD and East Murwillumbah flood levees would have been completely overtopped and the areas behind them inundated with up to four metres of water. The Dorothy William Street levee was overtopped and that area was under two to three metres of water. Watch a video on how a flood unfolds in the Murwillumbah CBD on Council's website at

Meanwhile, the March 2017 flood left South Murwillumbah looking like a war zone. And while many riverside residents stayed put feeling they would be safe in their elevated houses based on their past experiences, the floodwaters raged just below their floorboards in the dead of night.

The South Murwillumbah levee was badly damaged in 2017 and has since been repaired. Nevertheless, it will only protect the community from a small flood.

Outlook for the season

The Bureau of Meteorology says that after a dry start to spring we could be in for a wetter-thanaverage September to November, thanks to a La Niña effect expected to dominate bringing enhanced chances of rain across much of eastern Australia.

In the Tweed, while rainfall in April and May was well below average, June was right on point with 102.8mm against the average of 105.5mm and July was well above average with 155.8mm against an average of 62mm.

In the seven months to the end of July, we have received almost our entire average annual rainfall at 1407.4mm at Bray Park against the average of 1571mm.



New residents are more vulnerable

New residents are likely to be more vulnerable in a flood than those who have lived in the Tweed for a long time.

To know your risk, new residents are encouraged to talk with their neighbours about floods of the past and learn what natural flood signs they should watch for.

Warnings from nature most often are the first warnings. Warning signs could include rain for many hours; pooling and ponding water; rushing roadside gutters; dry watercourses running; livestock moving to higher ground; rising creeks and rivers.

Then, there's the official warnings. The Bureau of Meteorology issues Flood Warnings and Flood Watches, Severe Thunderstorm Warnings and Severe Weather Warnings, while NSW SES adds local information and issues Flood Bulletins, Evacuation Warnings and Evacuation Orders.

The scope of the BoM's agreed flood-warning service does not include warnings for local overland and/ or rapid onset creek (flash) flooding. This is particularly relevant for the Tweed Shire, given the multitude of creeks that run down its valleys.

Residents should not wait for official flood warnings but should act on the warnings of nature.

- If your home is likely to be flooded and you need to leave:

- The insurance industry in Australia defines flooding as: The covering of normally dry land by water that has escaped or been released from the normal
 - confines of:
 any lake, or any river, creek or other natural watercourse, whether or not altered or modified; or
 any reservoir, canal, or dam.
- All new home and contents insurance policies in Australia include flood cover, however many choose

to opt out of flood cover, exclude flood from business policies or choose not to insure at all. Cover for stormwater will not generally extend to include flood events. Policy holders should understand the difference and upgrade their policy if flood cover is required. If an initial quote is too expensive, shop around. How high can the rivers rise?

There are a number of river gauges throughout Tweed Shire that measure the depth of the water at all times.

Since records began, the maximum heights of the rivers at gauge locations are:

There are now three gauges that Bureau of Meteorology flood warnings will predict river heights for, namely:

1. Murwillumbah Gauge (located in front of the Murwillumbah Civic Centre)

2. Barneys Point Gauge (located on the old highway bridge abutment in Chinderah Village), and

3. Tumbulgum Gauge (located at the southern end of the village adjacent to Government Road).



Levee system

Tweed Shire Council owns and maintains the Tweed's flood levee system.

Residents should know levees do not protect against all floods. If a big enough flood occurs, any levee can be overtopped. Also, while levees are designed to keep river water out, during a flood they keep local rainwater in and act like a dam as the drainage outlets to the river are closed. What's your flood trigger?

Different communities will have different flood triggers. Even different people in the same community will have different flood triggers depending on their age, mobility, health, whether they have young children or a reliable vehicle and other factors.

Remember, every flood is different so you cannot rely solely on past experience.

To identify your flood triggers, check out the examples below to see if they might be relevant to your situation.

Flood trigger

BoM releases a Moderate Flood Warning for Murwillumbah

Move possessions from under storey or ground floor to upper floor



Action

Move possessions from under storey or around floor to upper floor or raise stock

When Moderate Flooding is predicted for Chinderah

When it's been wet for days and 300mm is predicted

When Major Flooding is predicted for Murwillumbah

tomorrow in the upper catchment

Leave and stay with a friend or relative

Evacuate to a designated evacuation centre



Who does what

The NSW State Emergency Service is the lead agency during floods and storms. NSW SES issues Flood Bulletins, Evacuation Warnings and Evacuation Orders. Flood Bulletins advise you of what is expected, the local consequences and how to prepare. An Evacuation Warning tells you to prepare to evacuate and an Evacuation Order tells you when and where to go. For more information go to www.ses.nsw.gov.au

The Bureau of Meteorology (BoM) is the official weather watcher and forecaster. It issues Severe

Thunderstorm Warnings, Severe Weather Warnings, Flood Watches and Flood Warnings. Visit www.bom.gov.au ABC Radio is the official emergency channel. Tune to ABC North Coast 94.5 FM or ABC Gold Coast 91.7 FM.

Council is responsible for closing local roads (not the Pacific Highway) when they are deemed unsafe or when directed by the Police or SES. Council also updates MyRoadInfo, which is the source of truth for road closures and road hazards in the Northern Rivers (but remember there can be a lag in reporting road hazards and closures due to the difficulty of getting information when roads into the Tweed's valleys can be cut early by both floodwaters and landslips).

Your local Community Action Team

After the 2017 March flood when many residents were caught out by just how quickly the flood unfolded, NSW SES proposed setting up a new volunteering opportunity for local residents to become more flood resilient and self-reliant.

- Two Community Action Teams (CAT) have now been officially formed in the shire and both have drawn up a set of actions to help their communities prepare and respond to a flood or storm emergency.
- Uki residents can contact their CAT group by telephoning Brendan Esposito on 0488 299 971. Tumbulgum residents can contact their CAT group by telephoning Sandy Copley on 0403 375 400.
