Meet this year's Tweed Australia Day Award winners

A combination of technology and tradition has come together for this year's Tweed Shire Australia Day Awards and Citizenship Ceremony.

The awards and citizenship ceremony were held online in the interests of public health - the first time Council had converted to an online event

Australian Seabird Rescue volunteer and Marine Science graduate Amanda Philp from Banora Point was named as the 2021 Tweed Shire Citizen of the Year.

Born and bred on the Tweed, Amanda has taken her passion for the area's marine life and its foreshore environment to heart, graduating from Southern Cross University with a Bachelor of Marine Science and Management. She is on call for the Australian Seabird Rescue as a volunteer and has rescued and looked after countless different animals and sea life in our local area

No matter the time of night or day, Amanda has no limits when an injured animal is in need of care.

The award recognised Amanda's dedication as a volunteer for the wildlife service and it was her work with animals which inspired her studies.

Council's General Manager Troy Green was the MC for the awards which saw recipients honoured in 5 other categories:

The 2021 Community Event of the Year goes to the Murwillumbah Arts Trail. Initiated by Creative Caldera, the Murwillumbah Arts Trail has been held 5 times since 2016 and last year's event featured 97 artists at 26 locations throughout the Tweed Valley, with Murwillumbah as the hub. It attracted a large number of visitors to the Tweed, contributing to the Tweed tourism market as well as engaging the local community and promoting our local talent.

An Honourable Mention in this category went to Music Trivia at South Tweed Sport Club for its social engagement with the community.

The 2021 Sporting Achievement (Individual) was shared by 2 people – sisters **Madison and Savannah Fitzpatrick**. The Cabarita Beach women are both members of Australia's Hockevroos team and represented the country at the 2021 Tokyo Olympics.

There were also 2 Honourable Mentions in this category – Jav Hov who is bringing soccer to children and adults with special needs, and promising young Murwillumbah swimmer Timothy Wellm.

The 2021 Young Achiever in Community Service award went to Pottsville's Sven Loemker. Aged just 17 years, Sven is a member of the Cudgen Headland Surf Life Saving Club and was recognised for his dedication to patrolling and his involvement in the club. In the 2020-21 patrol season, he racked up a massive 171.2 volunteer patrol hours one of the highest of the Far North Coast. He also spends a significant amount of his own time training and mentoring the club's juniors.

The 2021 Volunteer of the Year (Individual) award went to Murwillumbah SES Commander Grant 'Jack' Frost. Jack was recognised for his work in building relationships between the community and the SES, particularly around Tumbulgum. He has been instrumental in assisting to set up local community action/response groups in the Tweed and constantly keeps group leaders up to date with information regarding threats such as fire and flooding.

An Honourable Mention in this category went to Jake Swift for his service as a volunteer at the Murwillumbah Rural Fire Service and Tweed District Rescue Squad.

The 2022 Volunteer of the Year (Group) award was presented to the Tweed Broadwater Village Craft Group for its tireless efforts in providing breast cushions for women who have had breast surgery at Tweed and John Flynn Hospitals.

The group, with support from Southern Gold Coast/Tweed Zonta, has produced almost 3000 cushions as well as making knee blankets for patients at Wedgetail Palliative Care, baby beanies for Byron Bay Hospital and fundraising events for the Cancer Council, Wedgetail Retreat – Tweed Palliative Care and Tweed Hospital.

Each of the award recipients was featured in short videos which will be added to Council's website and YouTube page for viewing.

The 2022 Tweed Shire Ambassador of the Year Gemma Eaton and Council's Community representative and 2020 Citizen of the Year Jenny Hayes joined in the virtual ceremony.

The awards ceremony was followed by a Citizenship Ceremony, which saw 35 residents from 18 countries across all continents of the globe become the Tweed's newest Australians.

No-fail summer tip for your green bin

Is your green bin a little less fresh this time of year? With the intense heat, bins can get a bit trickier to manage.

However, we do have the key to a fresh smelling bin and a happier you.

Put meat and seafood scraps in the fridge or freezer, then place into your green bin on collection day. Hey presto! A fresh bin.



Simply gather meat and seafood scraps throughout the week and keep adding to it. There are a few options:

- · wrap it in newspaper or butcher's paper
- use a 100% Australian certified compostable liner labelled AS 4736 (look for seedling logo below)
- store it in a reusable container with a lid (i.e. yoghurt container), then empty contents into the bin on collection day (container can be reused or put in recycling bin).



You can reuse the same paper or liner, just unwrap, add scraps, wrap up and place back in fridge or freezer again.

Put an alarm on your phone at night or first thing in the morning to grab the bundle out of the fridge/ freezer and pop it in your bin.



Proposed modification

Basement level

 Modification to floor plan including provision of two additional carparking spaces, conversion of one car parking space to disability compliant, relocation of bicycle storage, relocation of the apartment storage areas, new pump room, new water tank.

Ground level

- · Changes to the floor plan.
- · Relocation of office premises to eastern frontage.
- Reduction in size of restaurant tenancy and associated dining area.
- Amendment to the toilet facilities provided and location.
- Changes to the awning lengths along Tweed Coast Road.
- Relocation of garden communal open space and removal of communal seating.
- Two tourist and visitor accommodation units along the western frontage
- Unit 1 including single bedroom and bathroom and a private balcony area.
- · Unit 2 including two-bedrooms, two bathrooms and a private balcony area.

· Minor changes to the floor plan including the removal of void area along the northern boundary.

Second floor level

- Removal of the four-bedroom dual use unit and provision of two, threebedroom dual use units along the eastern boundary.
- Changes to the ceiling height to grade from 2.6m at the rear western end to 2.7m to the frontage to ensure the building is within the 13.6m building height limit.
- . Changes to the floor plan to identically reflect the first floor.

- · Amendment of the elevations to match the floor level change identified above
- Inclusion of new materials including breeze blocks.

· Removal of the fit out of the restaurant tenancy from the consent. It is proposed that the restaurant tenancy will be delivered as a shell for future tenant to fit out via either first use development application or complying development certificate.

Any person may, during the period specified above, make a submission in writing to Council in relation to the Modification Application. Where a submission is in the form of an objection, then the grounds of objection are required to be specified.

Any person may, during the above period, make a written submission to the General Manager of Council. It should also be noted that Council has adopted a policy whereby, on request, any submission including identifying particulars will be made public. Council will give consideration to the "Public Interest" and requests for confidentiality by submitters in determining access to submission letters. However, the provisions of the Government Information (Public Access) Act 2009 -GIPAA may result in confidential submissions being released to an applicant.

Please note – requirements regarding Disclosure of Political Gifts and Donations

A disclosure is required to be made in a statement accompanying the relevant development or planning application by a person who makes the application. In addition, a person who makes a written submission either objecting to or supporting a relevant development or planning application must also make a disclosure if the person has made a reportable political donation.
