# **Dial-up bulk waste collection**

Residential bulk waste removal services in the Tweed are set to switch to a dial-up service from the middle of next year, to provide a service which is more convenient for households and addresses a number of issues with the current biannual kerbside collection it will replace.

A Council meeting last week resolved to award a new three-year contract for waste removal services in Tweed Shire, which begins in the 2016/17 financial year and includes a twice-a-year dial-up bulk waste collection for all rateable residential properties currently eligible for the existing kerbside service.

Under the current contract, one more 'business as usual' biannual kerbside collection will be conducted in the first half of 2017.

Last week's meeting endorsed the move to a dial-up service because it prevents illegal dumping, reduces the length of time items are left outside a home to less than 24 hours and increases the opportunity for recycling of materials. The new altered service will maintain the same level of service currently enjoyed by Tweed households with much greater flexibility about when they access the collection.

All eligible households will be able to phone twice a year to request a collection, when they have bulky items they need to dispose of, and be advised of the date they should be placed out for collection.

The bulk waste collection continues to be popular with Tweed residents and the vast majority of people do the right thing to make sure the service operates efficiently and cost effectively, with minimal disruption to the community. However, a number of people continue to misuse the service and this had a significant negative impact on some residents, including large piles of waste illegally dumped in a number of locations.

The personalised service offered by the dial-up option brings a more convenient collection, allows for suitable items to be redirected to recycling and removes the potential for misuse.

# Vandalism threatening the stability of river bank

Council is appealing for the community to dob-in the vandals who cut down trees in two areas of the shire and set fire to a new riverside planting last week.

Vandals used a chainsaw to cut down two well-established Weeping Lilli Pillis (Waterhousias) at Col Wiley Park, near Byangum Bridge, overnight on Friday 18 November. They condemned a third by cutting about 75 per cent through its trunk, forcing it to be removed by Council.

Then, early last week, Council staff discovered vandals had cut down about 20 river mangroves (Aegiceras corniculatum) and set fire to a new riverside planting of Lomandra in the same area.

The Lomandra planting, undertaken to complement the rock revetment stabilisation work and planted through jute matting, will need to be re-done adding an extra \$1,500 to the cost of the job.

All three acts of vandalism have been described by Council as 'senseless', as there will be no benefit to anyone from the destruction. The damage on the Tweed River bank, near the truck layby area, is more insidious.

"The bank where these mangroves have been cut down is undercut due to bank erosion and the loss of these trees will only accelerate the erosion," Acting Director Engineering Danny Rose said.

"This senseless vandalism is really disappointing because we are currently undertaking river revetment works along Tweed Valley Way to stop the Tweed River further eroding the bank towards the road."

# Bumper response to koala road safety initiative

Students from Mt St Patrick Primary in Murwillumbah have launched a series of bumper stickers at a special 'koala focused' assembly, aimed at making sure drivers take care in Tweed koala zones.

The school's Student Representative Council initiated the program after learning of the plight of the endangered Tweed Coast koalas through a workshop with Team Koala and Council.

In the workshop, the students developed a communication strategy focusing on reducing the number of koalas killed on local roads.

The students have then taken on implementation of the strategy which Council's Senior Program Leader, Biodiversity, Scott Hetherington said includes presentations throughout the school, composing a 'koala road' song and holding a bumper sticker design competition.

"Some of the great messages the students have developed have recently been added to the variable message signs on Clothiers Creek Road," he said.

"The bumper stickers will be a great help in making sure that drivers take care in koala zones, especially as we have identified through traffic monitoring that the peak travel through the zones is associated with traveling to work and school."

Team Koala received a community assistance grant to deliver the workshops and Mt St Patrick Primary is the second school to be involved this year.

"With the recent bushfires, the pressure to save our last remaining koalas has never been so great. Well done to this amazing school for putting in such a determined effort," Team Koala President, Jenny Hayes said.

### Park sparks nostalgic memories

Childhood nostalgia flowed during a small gathering to officially open the new-look Wilson Park at East Banora Point recently.

Wilson family members were joined by residents' association members, media and Council project officers to celebrate the new playground and open space, which replaces the old Wilson Park which made way for the Pacific Motorway bypass in 2012.

The new playground and space sparked many childhood memories for 83-year-old Ross Wilson.

Four generations of the Wilson family have lived in the Tweed since Ross's grandfather moved to the area in the 1880s. The family established a farm in Terranora some 110 years later, around 1990.

"There's no doubt about it, the old man would be very pleased with the way the park has turned out," Mr Wilson said.

"The kids' playground, in particular, has come up really well and a lot of kids are using it. This place really was paradise when I was a child and this space is still a lovely spot."

A few finishing touches, including a new water fountain and signage celebrating the Wilson family's connection to the site, were completed earlier this month in time for the official reopening on Friday 11 November.

The original dedication plaque to the Wilson Family was reinstated. Banora and District Residents Association President Cliff Clothier said it was an important recreational space for the area because it was the only large open public space in Banora Point, east of the highway.

"It's just great to have a playground here again and to see so many people using it," Mr Clothier said.

# Major drainage upgrade completed

Council last week completed a major drainage upgrade to a low-lying area prone to flooding in Pottsville.

The installation of stormwater pipes from Cudgera Creek (through North Pottsville Holiday Park, across Tweed Coast Road and parallel to Boronia Avenue) to Elanora Avenue will allow surface water to quickly drain to the creek during heavy rain.

The drainage upgrade is now complete, as Council upgraded the drainage north of Rajungra Avenue in 2010 following a severe flood in 2005 when the whole area essentially became a shallow dam.

The latest stage of the drainage upgrade took much longer than expected as Council uncovered multiple services along the stormwater drainage route.
