New tool available to check for NBN connection

The NBN rollout is well and truly underway in the Tweed, and with installation work becoming a familiar sight across the shire, Council is encouraging community members to access a new online tool to check when their residence will be connected.

The network, either through the fixed wireless service or fibre to the node, is now available to some 15,000 Tweed homes and businesses with a further 7000 expected to have access in the next few months.

Tweed residents and businesses can get an estimated timeframe of when the NBN will be available in their area by checking their address via http://www.nbnco.com.au/connect-home-orbusiness/check-your-address.html

Council General Manager, Troy Green, said improved access to high-speed internet is important to Tweed residents, particularly those in rural areas.

"One of the actions of Council's Economic Development Strategy is to promote opportunities to attract digital-related businesses, so this is great news for businesses who are looking to set up in the Tweed, as well as new residents," he said.

"We have such diverse communities here in the Tweed, from urban areas through to coastal towns and rural villages.

"This technology will provide people in the most isolated parts of the Tweed access to opportunities that others in the rest of the country take for granted.

"Access to fast and reliable broadband will mean better connectivity for residents and families, particularly when it comes to areas such as health and education.

"It will also help to support the growth of small businesses and industries that underpin our local economy, enabling them to expand and compete globally."



Access road and boat ramp upgrade imminent

A Murwillumbah boat ramp in Commercial Road, and its access road, will be upgraded in a project set to start later this month.

The cement ramp will be extended, its gravel road will be improved and each end of the road will be sealed as part of the \$162,000 project.

Work will also include construction of a 100-metre-long stretch of rock wall, tying into the existing rock wall to the north of the boat ramp, to protect the riverbank and adjacent car-trailer parking area.

Work is scheduled to take eight to 10 weeks to complete but will be conducted in three consecutive stages to minimise interruptions to users. Stage 1 will build the rock wall, with the northern section of the access road to be rebuilt as stage 2.

Stage 3 will extend the concrete boat ramp and rebuild the southern section of the access road.

Access to the boat ramp is expected to be interrupted for approximately two weeks. Signage with the dates the ramp will be closed will be installed at the site once those dates are confirmed.

The project has been funded through a \$117,000 Boating Now grant from Roads and Maritime Services.

Targeting tossers to stop littering

Litterbugs on our local roads and highways should be aware that anyone 18 or over can now report littering from vehicles and a fine from \$250 is likely be issued.

The 'Report to EPA' online service is part of a comprehensive State Government anti-littering program that aims to deter people from littering from vehicles by increasing the likelihood of being seen, reported and fined.

North East Waste has been working with north coast councils to roll out a roadside litter reduction campaign across the region to encourage residents to register and report littering from vehicles.

Karen Rudkin, North East Waste Litter Project Coordinator, said that the campaign sends a clear message that littering is unacceptable and that litterers will be seen, reported and fined.

"Roadside litter is one of our region's most unnecessary and preventable environmental problems. By registering and reporting littering from vehicles, you are part of the solution to the problem of litter," she said.

With the assistance of the Roads and Maritime Services, litter hot spots have been regularly monitored for six months. The first stage of the awareness campaign resulted in a significant reduction in the volume of litter in the majority of the hotspots.

The second stage of the campaign is about to commence with the ongoing support of a number of Tweed businesses who have again put their hand up to help spread to the anti-litter message, encouraging their customers to do their bit in helping to keep our community clean and litter-free.

ROAD WRAP

Road closures: RMS closure of Minjungbal Drive southbound onramp to Pacific Motorway for night roadworks on Midgungbal Drive median from 8pm to 6am from 20 to 30 March. Signage advising diversion to next southbound onramp via Sexton Hill Drive. Minjungbal off ramp will still be operating. Major upgrade of Tumbulgum Road, between Sunnyside Lane and Old Ferry Road, Murwillumbah (6-month closure). Pedestrians and cyclists can still pass through section with care but all vehicular traffic will be diverted around the site. Racecourse Road, Murwillumbah, near Tumbulgum Road, for Mayal Creek revetment works.

Temporary traffic lights: Henry Lawson Drive, between Coach Road and the Tennis Courts, Terranora.

PUBLIC EXHIBITION – DRAFT MARKETS POLICY

The *Markets Policy*, adopted by Council on 18 February 2016, has been reviewed. The review has incorporated an enhancement of the sustainability principles.
